Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Mayor Gaughan reported Village Halloween Parade and Party were successful and thanked Altamont Fire Dept; Altamont Fire Dept. Ladies Auxiliary; Patty Blackwood, Village Clerk and Kelly Best, Village Administrative Assistant. Village of Altamont Archives and Museum will hold "I Remember Altamont" art exhibit starting December 4th. Watercolor paintings by Mary-Ann Brock and Text by Carol Du Brin. Marijo Dougherty, Village Archivist, has received donations to help support art exhibit.

Paul Miller, Chief AFD, reported 5 calls for the month of October bringing total to 105 calls for the year. Eighteen members completed CPR and AED Certifications. Chief Miller stated he didn't have a report on the air tanks at this time due to waiting on pricing from the vendor.

Timothy McIntyre, Supt. of Public Works, reported he met with Barton & Loguidice and Green Mountain Pipeline Services, winning contractor for rehabilitation to sanitary sewer system. Rehabilitation will begin on November 8th.

Trustee Dineen made a motion seconded by Trustee Aylward to approve the Treasure's report; Abstract #10, Abstract #11, Abstract #12 and transfer of funds as submitted.

Public Comment:

Harvey Vlahos, Main Street, inquired about the Village property for sale located at 126 Witter Road, Town of Knox. Timothy McIntyre, Supt. of Public Works, stated fifteen years ago Village purchased property which leads back to Village's lower reservoir. Property was purchased for possible access point to the reservoir. Property has never been used by Village. Reservoir isn't used for Village water source. Village has been paying approximately \$680 per year in taxes. Mayor Gaughan stated one of the conditions of the sale of the property is Village would maintain a right-of-way.
