Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Keith Lee, Co-Chairman of the Parks Committee, submitted a Parks Report. Copy of Parks Report included with Official Minutes.

Mayor Gaughan, on behalf of the Board of Trustees, extended sympathies to Mary Schiable's family on her recent passing. Mayor Gaughan read two letters of commendation for Timothy McIntyre, Supt. of Public Works and Patrick Thomas, Altamont Police Officer. Mayor Gaughan reported Altamont Museum and Archives, under Marijo Dougherty's leadership, has 7 volunteers working in the museum. One of the volunteers is an intern from University of Albany. Mayor Gaughan thanked Ms. Dougherty and the volunteers for their great work.

Paul Miller, Chief AFD, reported Altamont Fire Department responded to 8 calls in September bringing total calls to 101 calls for the year. Tyler Fire Equipment will make a presentation on air packs on October 18th at 6:00 p.m. Chief Miller to get a list to Mayor Gaughan of the volunteer fire department members that are certified for internal work. Fire department Automated External Defibrillator training to be held October 25 at 6:30 p.m.

Donald Cropsey, Jr., Building Inspector; reported Planning Board approved preconcept plan for a martial arts studio. Village of Altamont has received their copy of 2010 Building Code of New York State.

Timothy McIntyre, Supt. of Public Works, reported water main flushing has begun this week and will continue over the next few weeks. Fall yard waste collection has begun this week and will continue through the beginning of December. Mr. McIntyre stated he met with NYS Department of Transportation regarding extending sidewalk on Western Avenue. NYS DOT approved Village to put in drainage pipe and catch basin in order to extend sidewalk to Gregg Road.
