Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Richard Straut, Barton and Loguidice, reported on waste water project. Paperwork for short-term funding has been finalized. Funding from Environmental Facilities Corporation should be in place and first draw should be within the next week. Design documents are fifty percent complete, major equipment has been selected, survey has been completed and drilling investigation for foundation design has been completed. Project is progressing nicely toward December completion date for submission to regulatory authority. Upcoming committee meeting will focus on plans in progress, financing and comprehensive review of the project.

Mayor Gaughan thanked Cindy and Jack Pollard, Home Front Café; Marijo Dougherty, Altamont Archives and Museum Historian and all those involved in the "I Remember Altamont" project. Mayor Gaughan reported Village Board of Trustees will continue to support history and culture of the Village of Altamont. Mayor Gaughan reported "Art in the Park" will be held on October 8th in Orsini Park, VFW will be holding chicken and biscuits fundraiser on October 8th, Altamont senior citizens will be taking a bus trip to Brooklyn, NY on October 26th and Village of Altamont Halloween celebration featuring "The Puppet People" will be held in Village Community Room on October 28th.

Timothy McIntyre, Supt. of Public Works, reported water main flushing will begin on October 11th and continue for two weeks. Fall yard waste collection has begun and will continue through November. Sludge tank structure was received and will be assembled in the next few weeks.
