Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Keith Lee, Co-Chairman of the Parks Committee, submitted Parks Report. Trustee Aylward noted the Parks Report detailed the very dry summer in the Village. Trustee Marshall acknowledged the thorough report presented by the Parks Committee and thanked them for their great job. Copy of Parks Report included with Official Minutes.

Trustee Marshall, Stormwater and Sewer Committee member, reported Committee met last month with Barton & Loguidice regarding change orders that occurred with general construction contract and electrical contract. There were a few change orders on each contract and it had to do with items that were initially unforeseen. Nothing extremely major and the contracts are still within budget that was previously approved by Village Board.

Mayor Gaughan reported 11th annual Victorian Holiday Celebration to be held on December 8th and 9th and thanked Altamont Community Tradition for hosting the event. Mayor Gaughan thanked Department of Public Works for putting up the winter greens, banners and lighting the trees in the Village. Mayor Gaughan reported winter parking regulations are in effect.

Todd Pucci, Chief Altamont Police Dept., reminded everyone to be responsible during this holiday season. Chief Pucci reported Albany County Stop DWI program is to be enforced in the "Drive Sober or Get Pulled Over" campaign which is in effect December 12^{th} – January 1^{st} .

Robert White, Chief Altamont Vol. Fire Dept, reported 4 calls for the month of November most being from alarm drops. The 45-minute air packs have been placed in service. Chief White thanked Mayor, Trustees and Village residents for their support throughout the year to the Altamont Vol. Fire Dept. Chief White reported, on behalf of the Herzog and Efaw families, a candlelight vigil will be held at Angel Park on December 6^{th} at 7:00 p.m.

Timothy McIntyre, Supt. of Public Works, reported parking regulations are in effect from November through April. Department of Public Works clears the Village sidewalks after a storm but reminded residents it's their responsibility to maintain their sidewalks. Trustee Dineen made a motion seconded by Trustee Aylward to approve the Treasurer's report; #9, #10 and transfer of funds as submitted. **Roll Call: All in favor**

Public Comment:

Judi Dineen, Altamont Community Tradition, reported 11th annual Victorian Holiday Celebration will be held on December 8th and 9th. Trustee Aylward acknowledged Altamont Community Tradition for all their hard work they put into the Victorian Holiday Celebration.

Maureen Ramirez, Altamont Rescue Squad, reported the Altamont Rescue Squad have initiated a community participation program and will be attending future Board meetings. Ms. Ramirez stated Altamont Rescue Squad will begin renovating their current building.

Richard Straut, Barton & Loguidice and Timothy McIntyre, Supt. of Public Works, on behalf of the Water Committee, reported five years ago Village completed a project to improve the water supply. Two new water wells were drilled on Brandle Road and water line was run into the Village to bring water supply to the Village. Along with that, the water filtration plant up on the hill was decommissioned and basically is an emergency water supply. That water plant was only able to operate part of the year and wasn't able to treat the water the rest of the year which left the Village with one well. Village now has three ground water wells that can supply its water supply. Over the last five years, the wells were monitored for their capabilities and they have proven to be very productive and be very good wells, as expected. At this point, there was question as to whether or not those wells would allow the Village to supply additional homes should that request come before the Village. From an engineering and water supply standpoint the Village would be able to supply water. The capacity that the Village has to produce water is more than double what the Village supplies residents today just to pump it out of the ground. Not necessarily to deliver it through the pipes but pump it out of the ground. The Water Committee has recommended that if water supply is to be expanded that it's taken step by step and start out with a fairly modest step of 25,000 gallons per day which is way below the 220,000 gallons a day, the average that the Village uses right now. The Water Committee is recommending to start with 25,000 gallons per day allocation and take it step by step and later evaluate and if sometime in the future the Village wanted to do more it could look at the system to see how it is responding and possibly increase it. The 25,000 gallons would service about 60 homes on a peak daily basis. Trustee Dineen did an evaluation of the properties available for development within the Village. Out of the 60 homes, 40 potentials are within the Village, not including the Altamont Fairgrounds, and 20 would potentially be served outside the Village. The Village has fees for connecting to the water system and also would also receive ongoing revenue from the sale of water. The analysis looked at how much revenue would be generated if 40 homes were developed in the Village and another 20 outside the Village. Out of those one-time fees it would be approximately \$447,000 in one-time connection fees. On an ongoing basis, if all 60 units were connected, \$43,680 per year would be generated in ongoing revenue. This is a fairly conservative low number. It assumes that those connected residents would only pay the base rate. There is potential that if more water is used they would pay more. The Water Committee suggested the Village may want to consider the policy because it's all about controlling water rates. The Village has an old water system. It has new wells but a lot of old pipes. Newest water tank is 17 years old, there are ongoing maintenance issues that need to be tended to and some water lines are not servicing very well due to frequent breaks and low pressure. In 2005 there were recommendations that were identified, along with drilling new wells, that the Village should consider that have been evaluated along with higher priority items totaling about \$1,000,000. There are on-going maintenance expenses and the Village may want to consider having additional revenue coming in to offset the costs. Phase II Water Policy is essentially to set the 25,000 gallons of water per day limit and allow development of 40 units within the Village and allow development of 20 units outside the Village. Any developer that was going to extend water lines would have to pay for it, have to meet Village standards and not exceed 25,000 gallons of water per day total cumulative allocation.

Richard Straut, Engineer of Barton & Loguidice; Altamont Village Board; Timothy McIntyre, Supt. of Public Works and Altamont Village residents discussed at great length the proposed Phase II Water Policy.

Trustee Whalen made a motion seconded by Trustee Dineen to modify Phase II Water proposal to propose that the gallonage of 25,000 gallons per day identified be specifically allocated as follows: 2/3 of gallonage would be allocated to within Village growth and 1/3 of gallonage, approximately 8,000 gallons, would be allocated towards potential growth outside of the Village.

Public Hearing at 8:30 p.m.

Michael Moore, Legal Counsel, opened public hearing with reading of the Legal Notice to consider proposed Local Law No. 3 of 2012, A Local Law adopting amendments to Specified Provisions of the Code of the Village of Altamont.

Trustee Whalen reported proposed amendments were primarily typos and clarifications to some individual paragraphs or sentences over the past three years. Code amendments include a substantial re-write to section 355-29, clarifying non-conforming uses, clarifying a description of recreational vehicle and clarification of sign area for free standing sign.

Counsel Moore reported a new definition of landscape business that was an outgrowth of a process that began at Zoning Board of Appeals a year ago when it was discovered the Code didn't have a definition for that type of business. Zoning Board of Appeals came

up with criteria that they thought appropriate and those criteria have largely been now proposed to be incorporated in the Code via this amendment.

Trustee Whalen reported changes to the Code have been collected for almost three years. They were items that had come up at the Zoning Board of Appeals meetings and this is the collection of those. Code updates are made in this way because it cost the Village a significant fee with the publishing house that puts the Code together. It cost the Village each time the Code is updated that's why it's being done as a collective.

No comment from the public.
