Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Mayor Gaughan reported there will be an active and exciting schedule this summer for the Village of Altamont Archives and Museum. Copy of Village of Altamont Archives and Museum report included with Official Minutes. Altamont Archives and Museum has received a \$1000 donation from CM Fox and \$250 donation from Fredendall Funeral Home.

Larry Adams, Assistant Superintendent of Public Works, reported street patching and slurry seal on Village streets to begin. Village does its own patching and the slurry seal is hired out. Jetting of the sewers is to be completed in June.
