Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Mayor Gaughan reported Village office will be closed on Veterans Day and asked all to think about the sacrifices our veterans have made. Mayor Gaughan reported there will not be a public hearing tonight on expending \$13,744 from the Water Reserve Fund for emergency well repair on Brandle Road due to a lightning strike. The Village received reimbursement from their insurance company covering all but the \$1,000 deductible. Mayor Gaughan reported hydrant flushing has been extended to November 13th.

Christopher Laurenzo, Altamont Police Dept., reported parking regulations are in effect from November through April.

Marijo Dougherty, Archives & Museum, reported Ed Bradt donated three scrapbooks of material on auto racing during the 1920's and 1930's at the Altamont fairgrounds. Ms. Dougherty reported Keith Lee, author of "Images of America: Altamont" will be at the Altamont Free Library on November 11th. Mr. Lee will be speaking about the research he did for the book.
