Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Jeffrey Moller, Supt. of Public Works, reported Dept. of Public Works has finished up crack sealing on blacktop. They will now be working on sidewalks on Western Avenue and portion of Altamont Boulevard and doing blacktop patching. End of the month DPW will be working on an INI problem with the sewer plant. Mr. Moller stated he will be working with Barton and Loguidice, Engineers, regarding submittal of Green Application.

Glenn Hebert, Building Inspector, reported he is gearing up for the annual fire inspections in June which will entail locating Knox Boxes on some of the businesses in the Village. Knox Boxes help the fire department to gain access without causing damage to the building. Knox Boxes are enforceable under the Fire Code.

Mayor Gaughan reported Archives and Museum will be hosting two exhibits this summer. The first is "Speed: Dirt Track Racing at the Altamont Fair", and the second is an exhibit on the stain glass windows of the churches of Altamont. Mayor Gaughan reported the Village will be very active this summer with the summer camp program, library concerts, and fire department movies in the park.
