Mayor Gaughan called the meeting to order with the Pledge of Allegiance.

Mayor Gaughan congratulated Betty Head on her selection as the Albany County representative on the Hudson River Valley Greenway Council Board. Ms. Head was nominated by the Altamont Village Board of Trustees on April 7, 2015.

Marijo Dougherty, Archives & Museum, thanked the volunteers of the archives and museum for their wonderful work at the October 18th celebration of the Village's 125th anniversary and hosting the exhibit on the stained glass windows of the churches of Altamont. Ms. Dougherty thanked Senator Amedore, Patricia Fahy, Geoffrey Brown, and Altamont Community Tradition for sponsoring the event. Ms. Dougherty stated the "Remembrance" catalog on the churches of the Village is available for sale at the Village office.

Jeffrey Moller, Supt. of Public Works, reported hydrant flushing was completed at the end of October. There was one water main break as a result of the hydrant flushing. Mr. Moller stated yard waste collection will continue until the snow falls. Mr. Moller reminded residents to keep the creeks clear and not throw leaves in the creeks.

Todd Pucci, Chief Altamont Police Dept., reported parking regulations are in effect from November through April.

Village Law §3-312(3)(b)(2), at a quarterly salary of \$710 effective December 1, 2015.

One part of the larger grant targets \$25,000 for the rehabilitation of the roof of the Historic Crounse House. We recognize the efforts of Assemblywoman Patricia Fahy for her efforts in procuring the funds in the State Legislature. **Roll Call: All in favor**

Trustee Dineen made a motion seconded by Trustee Marshall to approve discussion on December 1, 2015 on the long-range plans for the use of the Crounse House property.

Trustee Dineen made a motion seconded by Trustee Marshall to approve authorizing the completion of paperwork with NYS Department of State to access \$10,000 to support activities and programs related to Altamont's 125th celebration. We recognize the efforts of Assemblywoman Patricia Fahy for her efforts in procuring the funds as an Assembly Special Project grant. **Roll Call: All in favor**

Trustee Dineen made a motion seconded by Trustee Marshall to approve authorizing completion of paperwork with the Department of Transportation to access \$50,000 to support the emergency repair of a culvert on Brandle Road within the Village. We recognize the efforts of Senator George Amedore for his efforts in procuring the funds for this project. **Roll Call: All in favor**

Trustee Dineen made a motion seconded by Trustee Marshall to approve authorization to sell following surplus equipment: 2006 Chevy Impala Vehicle at minimum sale of \$3,000 per recommendation of Todd Pucci, Police Chief. **Roll Call: All in favor**
