Mayor Dineen called the meeting to order with the Pledge of Allegiance.

Keith C. Lee, Co-Chairman of the Parks Committee, inquired if the Village Board was going to be hiring gardeners to replace Deborah Guilfoyle who resigned in December and Anne Best who is cutting back her hours. Mayor Dineen stated the Village will be advertising for one or possibly two gardeners next week in the Altamont Enterprise.

Mayor Dineen reported there are budget workshops scheduled for this month and next month. Meetings are open to the public and held in the Village Hall. Mayor Dineen stated there is a new hallway exhibit celebrating the Altamont Fire Department's 125<sup>th</sup> anniversary. Kelly Best, Administrative Assistant, assisted with setting up the hallway exhibit. A lot of what Kelly put out for the current exhibit were the works of Marijo Dougherty. Ms. Dougherty put together an exhibit of the Altamont Fire Department shortly after being hired as curator of the Village many years ago. Mayor Dineen welcomed everyone to stop by and see the exhibit.

Todd Pucci, Chief Altamont Police Dept., reported winter parking regulations are in effect until April. Chief Pucci asked everyone to be off the streets from midnight to 7:00 a.m.

Paul Miller, Chief Altamont Fire Dept., submitted a Chief's report for January. Copy of the Chief's report included with Official Minutes.

Jeffrey Moller, Supt. of Public Works, asked residents to please not park on the streets due to the impending snowstorm. Public Work's employees will be throughout the Village clearing snow. Mr. Moller reported water meter reading will begin the end of February beginning of March.
