Mayor Dineen called the meeting to order with the Pledge of Allegiance.

Todd Pucci, Chief Altamont Police Dept., asked the Village Board if they would consider putting a snow emergency in affect for the upcoming snowstorm. It is being reported that the Village of Altamont will be getting 10-16 inches of snow.

Trustee Fahrenkopf made a motion seconded by Trustee Whalen to approve the Village of Altamont declare a snow emergency from noon on Wednesday through Thursday at midnight. No parking on Village streets. **Roll Call: All in favor**

Paul Miller, Chief Altamont Fire Dept., submitted a Chief's report for February. Copy of the Chief's report included with Official Minutes.

Jeffrey Moller, Supt. of Public Works, thanked Chief Pucci for the suggestion of the Village declaring a state of emergency. Mr. Moller stated Public Works Dept. had a lot of problems with residents not cooperating on the streets with the last snowstorm. Mr. Moller reminded residents to pay attention when walking in the streets and be watchful of snowplows and to keep the kids out of the snowbanks near the streets. Trustee Whalen and Trustee Fahrenkopf reminded residents they are responsible for clearing their sidewalks of snow and ice and asked residents to clean out the fire hydrants near their homes. Mayor Dineen stated she was stopped by two residents that commented on the good job Public Works did with the snow removal on the last snowstorm.
