per week at a salary of \$15.00 per hour per recommendation of Todd Pucci, Chief. Position is probationary for a period of up to one year. After successful completion of probation, salary will be increased to \$16.00 per hour. **Roll Call: All in favor**

Trustee Whalen made a motion seconded by Trustee Scally to approve authorizing Mayor Dineen to sign Capital Region Solid Waste Management Partnership Planning Unit Recycling Coordinator Intermunicipal Agreement per recommendation of Jeffrey Moller, Supt. of Public Works. **Roll Call: All in favor**
