Lot 610, Map 1C, Antrim, County of Hillsborough, and State of New Hampshire to be subdivided into lots 610-28 and 610-29 and further subdivision of lot 610-28 into a Cluster Subdivision of 27 single family residential lots and an open space lot to be known as lot 610-28.

Time shall be of the essence of the Owners' performance. If the following contingencies are not met by December 31, 1991 this approval will be null and void.

1. Post performance bond, an irrevocable letter of credit (from a recognized bank or savings/loan institution acceptable to the Town of Antrim) or other form of security acceptable to the Town of Antrim and its Attorney in the following amounts:

- 3. Sign the Development Agreement.
- 4. Sign the Declaration of Covenants and Restrictions for Great Brook Subdivision, Antrim, New Hampshire.

The Town of Antrim will not accept any improvements which have not been inspected throughout construction by the Town Engineer. In the event that the owners shall elect to perform any work on the site prior to the execution of the Development Agreement and the delivery of the bonds and escrow (paragraphs 1 & 2 above), then before any work is done on the site the owner shall:

- *1. Post performance bond, an irrevocable letter of credit (from a recognized bank or savings/loan institution acceptable to the Town of Antrim) or other form of security acceptable to the Town of Antrim and its Attorney in the following amounts:
 - a. Disposal of stumps

b. Temporary erosion and sedimentation control

\$ 5,000.00,

c. Landscaping and reseeding in case bonds are not posted and project is not completed

- *2. Deposit in an escrow account with the Town of Antrim the following sum in good funds for inspection by the Municipal Engineer. \$ 18,315.00
- 3. Owners shall be responsible for coordinating necessary inspection with B. G. Miller Associates, 15 Water Street, Concord, New Hampshire, Municipal Engineer at sufficient intervals as required by B. G. Miller Associates and shall hold such preconstruction meetings with B. G. Miller Associates as shall be required to assure appropriate construction and inspection during the work in process.
- * Note: Any bonds posted or escrow established prior to meeting the requirements of the Conditional Approval will reduce the amount necessary to meet those requirements
