He then read a letter from abutters Philip and Ann Dwight in favor of the This was made of the record. Franz Andlinger presented his case, he has a wood fired brick oven which he plans to use in baking bread. This bread will supply his store in Concord (Bread and Chocolate) and he plans sell some of the bread out of the Clinton Road location. He testified that there is space for five or six cars. He will be required to comply with the health rules for the State of New Hampshire. There was no testimony against the proposal. Chairman Rowehl noted that this property consists of two parcels across the street from each other although they are described in one deed, and questioned if it complied with the rules for a home based business. It was noted that the location has been used through the years as an antique shop, a bakery, an apartment and now Mr. Andlinger wishes to use it as a bakery again. Chairman Rowehl and David Essex had questions about the definition of a home based business as opposed to a retail store. The balance of the Board was of the opinion that this is not an issue. Hugh Giffin commented that the building in fact is used and has been used as an accessory building although taxed as a separate lot. This is due to the fact that the two lots are separated by Clinton Road (Route 31). Hugh Giffin moved to accept the application of Franz & Linda Andlinger for the Site Plan Review on tax map 5 lot 131. applicant proposes to operate a bakery from this property on Clinton Road in the Rural District.
