

Minutes of Selectmen's Meeting June 27, 1977

All three Selectmen present, Eric F. Tenney presiding

Ted Hardwick had the Selectmen sign applications for insurance on Town Buildings, the old policies have expired and he has to write new ones.

Merle Aborn reported to the Selectmen, it was brought to his attention that the sand for the parking lot should have been taken from the fill that was offered by townspeople, Merle stated that he believed that these people should have come forward and not waited to be asked. The men have gone to New Jersey to pick up some surplus equipment given to the Town by the Government. Merle also notified the Selectmen that George Cole and Robert Varnum want two weeks vacation and would like to start fourth of July weekend. The Selectmen said that if it was agreeable with Merle it was agreeable with them. It was stated that there will be no meeting next Monday because it is the Fourth and the time should be in by Friday.

The Millers a couple who are planning to buy the Price place on Brimstone Corner Road met with the Selectmen and Merle Aborn to discuss what they, the Selectmen, can do about keeping the road open for the Millers this winter. The Selectmen suggested an article in the Warrant next Town Meeting and meanwhile they will see what they can do.

Donald LaRouchelle met with the Selectmen about his Veteran's Exemption for the past year. It was granted.

Russell Cuddihy met with the Selectmen to discuss selling a piece of his property the Selectmen directed him to the Planning Board since what he is doing constitutes a small sub-division. Russ stated that the fence at the ballfield is coming along nicely and that the Beach has opened without any problems except that there is a small thing with the plumbing and it is being repaired.

Donald Dunlap met with the Selectmen and secured a sign permit for a sign on Route 202.

Barry Frosch and Mike Beauchamp met with the Selectmen to discuss the status of the Workmen's Comp as it concerns the Rescue Squad. The Selectmen said that the conditions of the original charter is what is causing the problems. Mike asked if Eric would speak to the squad at its next meeting. Eric told them that he thought that Town Counsel could explain it better. Barry and Mike will talk to Lloyd.

Barry Frosch mentioned to the Selectmen that there are cars on the Ballfield again and they are tearing it up. The Selectmen will refer this complaint to the Chief.

Eric asked Emery Doane to write a letter to Bruce Cuddihy and Wayne Olson making an offer of the assessed valuation for the Dorothy Robertson property on Jameson Avenue, for the purpose of a skating rink as voted at Town Meeting 1977.

Dick Schacht called the attention of the Selectmen to the fact that Mr. Nylander had donated her husband's flag to be flown over the Fire Station. It will need to be lighted because taking it down each evening could be overlooked. The Selectmen agreed.

The Selectmen reviewed the statement for the press in regard to the Hearing Wednesday June 22, 1977 in regard to the location of the Sewage Treatment Facility. The Selectmen agreed on the statement in its final form.

The Selectmen were provided with copies of the Proposed Sub-Division Regulation Revision and the Performance Bond Requirements for their perusal. These were provided by Emery Doane, Representative to the Planning Board.

Chief Craig met with the Selectmen and gave his report for the week.
