K.Ring asked who devised monster which is used to cut sides of road. The Town loader is all they have to do the job of cutting the side of road. It has been in use for this purpose for many years. To rent a cutter would cost \$15 to \$20 an hour. J. Jones suggested a brush hog would do the job and should in the end save money as well as time. Nothing more said on this. George was asked if he had agreed to clean up after a tree cut on private property. He had been asked by Public Service if he would clean up if P.S. did the cut. He told P.S. to speak to him after he had checked out the tree, but heard nothing more from them. Property owners are responsible for the clean up of trees on their own property. George will take a ride around Town and make a list of dead trees in need

James Trow and Mike Anderson from Continental Telephone was in to speak of the cable they will be installing in the Town. Asked if there has been any problem with cable already put in and was told no. J. Jones asked if the Town could have a map showing where cable is burried and J.Trow said he will make a copy of one after the job is finished and see that the selectmen get one. Mr. Anderson had a map that he is using and showed the selectmen what he had in mind. Asked who would be responsible should a cable be broke due to clearing of land or plowing. Should any cable be broken, a call is to be made to the Telephone Co. and a man will be sent to make needed repairs with no cost to town nor property owner. Any cable installed by culverts will be marked but there is always a chance of damage being done while work is going on in an area.

Mr. Grabowski objected to the minutes making no mention of which Town they were from and not being signed. He wanted the minutes changed to show why he came in and wording changed. He said he did not say Keene Gas was leaving because they were fed up with Antrim, but rather said "probably fed up". Selectmen had accepted the minutes and saw no reason to change them. Last year the State was asked what should go into the minutes and secretary was told at that time, Selectmen present, time, topic of discussion and any decisions made. (Actual discussion was not needed in minutes.) Any votes taken and how each selectman voted. Mr. Grabowski said he will check with the Secretary of the State. He told the selectmen they had double standards and asked how many sets of minutes were kept. He was told that he had a copy of the only set of minutes kept.
