TELECTMEN'S MEETING MONDAY, APRIL 14,1984

FRESENT: RACHEL C REINSTEIN, JOHN J JONES AND KEITH BOATRICHT. MEETING CALLED TO ORDER AT 7:30PM WITH THE PLEDGE OF ALLEGIANCE.

CHECKS WERE SIGNED AS WERE BUILDING PERMITS FOR CHRISTOPMER JOSEPH . THIS PERMIT WAS SIGNED AFTER THE LOT SIZE WAS CHECKED AND THE PLANNING BOARD RECORDS WERE CHECKED TO CONFIRM THE APPROVAL OF TWO NON-CONFORMING BUILDING LOTS WERE APPROVED BACK IN 1977. FILE # 76-7. TUCKER BROOKS BUILDERS. PERMIT FOR ROSER CROTEAU REFUSED. MUST SO TO BOA FOR SET BACKS AND APARTMENT VARIANCE

MINUTES OF LAST WEEKS MEETING APPROVED.

EILLS FOR LLOYD HENDERSON WERE DISCUSSED. ALTHOUGH THERE ARE SOME QUESTIONS AS TO RESULTS FROM CALLS AND LETTERS, SELECTMEN SEE NO REASON TO WITHHOLD PAYMENT.

EOB VARNUM GAVE HIS WEEKLY REPORT. HE WILL SHUT DOWN LIBERTY FARM ROAD TOMORROW AND TO WORK ON THE BRIDGE. ROAD CREW CLEANED OFF THE BRIDGE TODAY AND GOT IT READY FOR THE REPAIRS.

SALMON BROOK ROAD HAS BEEN FIXED AND MADE PASSABLE FOR CARS.

JOHN GRANTS LOGGING HAS BEEN SHUT DOWN. JOHN WAS PULLING LOGS FROM THE TENNEY PROPERTY AND HAS MADE A MESS OUT OF THE ROAD AND LEFT A MESS IN THE WOODS. HE WILL HAVE TO PUT GRAVEL IN AND CLEAN UP: THE AREA.

EVERETT CHAMBERLAIN ONCE AGAIN QUESTIONED THE VALUE PLACED ON HIS BROTHER NORMAN'S PROPERTY. SELECTMEN AGREED TO HAVE THE APPRAISER CHECK OUT THE PROPERTY WHEN THEY DO THE PICK-UP WORK IN MAY.

MR CHAMBERLAIN ALSO MENTIONED A PROBLEM WITH CARS PARKING ON THE SIDEWALK IN FRONT OF THE CHIRICHIELLO PROPERTY. WHILE WALKING THEY ARE FORCED TO WALK IN THE ROAD OR SQUEEZE BY THE CARS PARKED ON THE WALK. SELECTMEN MENTION IT MAY BE POSSIBLE TO MARK OFF THE PARKING AREA. AND PLACE NO PARKING SIGNS ON THE WALK.

HE ALSO REPORTED AN OLD TREE STUMP IN FRONT OF HIS PLACE WHICH HE WOULD LIKE TO SEE COME DOWN.

DAVE PENNY AKED IF THE SELECTMEN WOULD SEE TO THE REMOVAL OF AN OLD DEAD TREE BY THE LIBRARY. IT IS A DANGER AND IT IS ON TOWN PROPERTY. THIS WILL BE MENTIONED TO BOB VARNUM.

DAVE ALSO MENTIONED THE DAMAGE TO THE BEACH PROPERTY AND LACK OF POLICE PATROLLING THE AREA. THE FENCE IS BROKEN, DAMAGE TO THE BUILDING AND HE HAS SEEN DRINKING ON THE BEACH AND DRIVERS TAKING OFF AT HIGH SPEEDS. THERE IS A LOT OF BROKEN BOTTLES ALL OVER THE BEACH WHICH COULD CAUSE PROBLEMS IF THEY ARE NOT CLEANED UP. THIS WILL BE REPORTED TO THE POLICE DEPARTMENT AND THE PARK DEPARTMENT.

REPAIRS FOR THE NORTH BRANCH STATION WILL COME TO ABOUT \$175. REQUEST WILL BE DISCUSSED WITH HANK CUTTER, FIRE CHIEF BEFORE APPROVAL IS GIVEN FOR THE REPAIRS TO TAKE PLACE.

LLOYD HENCERSON HAS ASSURED THE SELECTMEN THAT A ZONING VIOLATOR WILL BE SERVED PAPERS ON WEDNESDAY.

SELECTMEN HAVE AGREED THAT JANE HILL AS HEALTH AND WELFARE OFFICER IS TO TAKE OVER THE DUTIES OF THE WELFARE OFFICER BY FILLING OUT THE VOUCHERS AND KEEPING THE RECORDS OF THE APPLICANTS. SELECTMEN QUESTIONED WHO IS TO FOLLOW UP ON THE SEPTIC COMPLAINTS. ALTHOUGH JANE HAS BEEN ELECTED AS HEALTH AND WELFARE OFFICER, THE TOWN HAS NO PROVISIONS FOR A HEALTH OFFICER. SELECTMEN WOULD RECONSIDERED THE BOARD OF HEALTH IN THIS CASE. IT IS POSSIBLE HEALTH OFFICER WAS ADOPTED BY TOWN WARRANT WHILE A PRECINCT WAS IN EXISTANCE. SECRETARY WILL CHECK WITH WATER POLLUTION AND CONTROL TO SEE WHAT CAN AND SHOULD BE DONE.

AND AREA TO MARKET AND MORTHLAW BUTTER OF THE TWO TO ARE ILL MICE THAN THE READ AND ABANDONED FOR MORE THAN THE THAN THE TOTAL IT CAN NOT BE REOPENED AS A SAW MILL. BUILDING IS NOT GRANDFATHERED. A QUESTION AS TO POSSIBLILITY OF OBTAINING A SEPTIC PEMIT WAS RAISED.

IT WAS AGREED TO ORDER 100 BUILDING PERMITS AND 100 ZONING BOOKS.
