SELECTMEN'S MEETING MONDAY, APRIL 21,1786

PRESENT: RACHEL C REINSTEIN, JOHN J JONES AND KEITH BOATRIGHT. MEETING CALLED TO ORDER AT 7:30PM WITH THE PLEDGE OF ALLEGIANCE.

CHECKS WERE SIGNED AS WERE BUILDING PERMITS FOR WALATER & KATHRYN TYLER. DAVE CUTTER & DAVE BOULE. A BUILDING PERMIT FOR WALTER & JOAN READ WAS DENIED. WILL NEED OBTAIN VARIANCE FROM BOA MINUTES OF LAST WEEKS MEETING APPROVED.

BOB VARNUM GAVE HIS WEEKLY REPORT. LIBERTY FARM ROAD HAS BEEN COMPLETED. HE HAS MADE 300 YARDS OF PATCH WHICH HE WILL PUT AROUND TOWN. PLANS TO GET TO SMITH ROAD ON MONDAY. MAY REQUIRE CLOSING THE ROAD FOR A DAY OR TWO. FIRE STATION PARKING LOT AT NORTH BRANCH HAS BEEN HAS BEEN REPAIRED. PROBLEM AT THE ADEN RING PROPERTY IS NOT THE RERSPONSIBILITY OF THE HIGHWAY. LAST YEAR REPAIRS WERE DONE TO TRY TO HELP WITH THE WATER PROBLEM. IT IS NOT CAUSED BY THE ROAD NOR THE CULVERTS. REPAIRS FOR THE NORTH BRANCH STATION WILL COME TO ABOUT \$175. AFTER SPEAKING TO FIRE CHIEF, APPROVAL WAS GRANTED FOR THE REPAIRS.

SELECTMEN HAVE HAD REQUESTS TO REPAIR HAWTHRONE COLLEGE ROADS. BOB WILL DO THE REPAIRS NEEDED WHEN HIS CREW HAS COMPLETED THE ROADS IN GREATER NEED. IF THEY DO NOT DO PIERCE LAKE ROAD, TURNER HILL ROAD, AND ELM AVE, THEY WILL LOSE THOSE ROADS. THE COLLEGE ROAD IS BUMPY, BUT NO WORSE THAN THE AVERAGE ROAD DURING THIS TIME OF YEAR. BOB CAN NOT JUSTIFY THE USE OF TOWN TAX MONEY REPAIRING ROADS WHICH ARE NOT IN BAD SHAPE WHILE NOT ATTENDING THE WORSE ROADS IN TOWN. BOB WILL MAKE UP A LIST OF PRIORITY ROAD REPAIRS. HE WANTS THE ROADS REPAIRED PROPERLY IN ORDER FOR THEM TO HOLD UP. BOB LET THE SELECTMEN KNOW HE WILL NOT LOAN TOWN EQUIPMENT OUT AS HAS BEEN DONE IN THE PAST.

DUE TO FAST DAY NEXT MONDAY, SELECTMEN HAVE DECIDED TO MEET ON TUESDAY.

LETTERS TO POSSIBLE ZONING VIOLATERS WHICH WERE UNCOVERED WHEN THE REASSESSMENT TOOK PLACE, WILL GO OUT THIS WEEK.

BRIAN BROWN, POLICE CHIEF AND LLOYD HENDERSON, SPOKE OF THE VIOLATOR WHICH WAS TO BE SERVED LAST WEEK. PAPERS TO BE SERVED THIS TUESDAY. SELECTMEN ASSURED BOTH BRIAN AND LLOYD THAT A LETTER HAD ALREADY GONE OUT TO ONE OF THE QUESTIONABLE VIOLATORS TODAY AND THE OTHERS WILL FOLLOW. SELECTMEN SAW NO REASON THE PAPERS WERE NOT SERVED ON THE ONE VIOLATOR SINCE THE VIOLATION TOOK PLACE AT LEAST A YEAR AND A HALF AGO AND LLOYD AND BRIAN WERE TO SERVE THE PAPERS AT THAT TIME. BOTH BRIAN AND LLOYD INFORMED THE SELECTMEN THAT THE OTHER VIOLATIONS MAY HAVE BEEN FOR A LONGER PERIOD OF TIME. SELECTMEN AGREED THIS MAY BE TRUE, BUT THE SELECTMEN WERE NOT MADE AWARE OF THEM UNTIL AFTER THE REASSESSMENTS.

BRIAN BROWN REQUESTED AN EXECUTIVE SESSION. SELECTMEN ALL VOTED TO APPROVE THE EXECUTIVE SESSION. MEETING CALLED TO ORDER. NO DECISIONS CAME OUT OF THE EXECUTIVE SESSION.

EIGHT OCLOCK APPOINTMENT DID NOT SHOW

M. TROBLEY WAS CAUTIONED TO MAKE SURE THE PROPERTY SHE IS LOOKING TO PURCHASE HAS BEEN SUB-DIVIDED, THAT SHE HAS A ROW THROUGH THE PROPERTY OF THE PRESENT OWNER OR THE ADJOINING PROPERTY. SELECTMEN GAVE HER A LIST OF THINGS WHICH SHE SHOULD BE AWARE OF BEFORE PURCHASING THE PROPERTY. THERE IS ALSO THE QUESTION OF HAVING A TRAILER ON THE PROPERTY. THIS WOULD HAVE TO GO TO THE BOA FOR A VARIANCE.

JOHN JONES ASKED THAT THE OFFICE BE CLOSED FROM NOW ON TO THE PUBLIC ON FRIDAY IN ORDER TO HAVE WORK DONE WITHOUT INTERRUPTIONS. THERE IS SUCH A BACK LOG OF WORK IN THE OFFICE AND IN THE SELECTMENS OFFICE AND MORE WORK CONTINUES TO COME TN. ALL SELECTMEN AGREED TO THE CLOSING OF THE OFFICE ON FRIDAY.

WHAT HER BUDGET IS AND THE PROCEDURE FOR FILLING OUT THE VOUCHERS. JAKE IS WILLING TO DO THIS AND KEEP IN TOUCH WITH THE SELECTMEN ON HER OUTLAY.
