

SELECTMEN'S MEETING, Monday, June 15, 1987

Present: John J. Jones, Chairman, Rachel Reinstein, Chris Joseph, Police Chief, Jackie Cottle, Mr. C. J. Grabowski and Elizabeth Shaw, Secretary.

Meeting came to order at 7:30 PM.

Chris Joseph reported the breakdown of the police cruiser. (Threw a rod and went on fire.) Chris checked with Lloyd to see if money can be withdrawn from Capital Reserve. Since the cruiser is needed for the Police Dept. to do their work, the expense to purchase a cruiser at this time will come out of the Police Dept. budget. A request for removal of \$10,000 from the Capital Reserve fund set up for the purchase of a cruiser and an additional \$4,000 to cover the cost of the cruiser will be made at a Special Town Meeting. This money will then be credited to the Police Dept. budget. The new cruiser is expected within a week.

Selectmen signed checks and building permits for Gray Stacy and Stephen and Ellen Mosher.

Minutes of meeting held June 8 accepted as written.

Mr. Grabowski objected to the minutes of the Selectmen's meeting held on June 1. Selectmen checked over the minutes and found no problem with them.

Selectmen discussed the complaints which they have received due to the closing of the landfill on Sundays. Neither Bennington nor Antrim Selectmen have been able to locate someone to work on Sunday at the landfill.

Chris Joseph and Bob Varnum, Road Agent, painted one cross walk today. They hope to get the remaining cross walks over the week-end.

A hearing on proposed zoning changes will take place on July 9th.

John Jones contacted Jack Prewitt's office at Bank East to acquire information as to the best way to handle the Farmers Home bond. A copy of the letter received from Farmers Home has been sent to Mr. Prewitts' office.

Rachel Reinstein gave a rundown on her meeting with the Southwest Reg. Planning in regard to the administration of the grant for the Community Project .

Selectmen agreed if Lloyd Henderson finds no legal problem with a Bible class using the Town Hall, the charge will be \$25.00 a day or \$75.00 for the three mornings it will be in use.

Selectmen will check with Gordon Allen to acquire some information on the rumor of the proposed changes to the Town Gym.

Mr. Page, Kincaid Construction, spoke of his confusion over the proposed changes on the zoning regulations. Mr. Page asked what can be done with the odd shape lot which he plans to buy. Selectmen thought any applications received before the proposed changes are posted would be grandfathered. This will be checked out with Lloyd Henderson.

Selectmen and Road Agent, Bob Varnum agreed to repair Mr. & Mrs. Lakus' driveway. This driveway was washed out during the flood. Bob agreed to put the driveway back in the condition it was in prior to the flood although he is not sure the washout was the result of the new culvert as Mr. Lakus proposed.
