

SELECTMEN'S MEETING, Monday, August 31, 1987

Present: John J. Jones, Chairman, Rachel C. Reinstein, Ed Rowehl, Chris Joseph, Police Chief, and Elizabeth Shaw, Secretary.

Meeting came to order at 7:30 PM.

Minutes for last weeks meetings to be amended to read, Mr. Foley left with the understanding if the Town accepts the road at the March Town Meeting, and no repairs are required as of April 1, 1988, the Town will begin to maintain the road April 1, 1988.

A building permit for Stephen & Dianne Platt was approved

A permit for Summit Associates was signed and approved pending approval of a newly designed septic system. The septic approval which was attached to the permit application was no longer valid. The location of the house and septic had been changed from the original designed.

A building permit for Gary & Janet Gagnon was denied due to set back requirements.

Selectmen voted to continue coverage on the copy machine.

Chris Joseph gave his views on the need for services from Peg Gagnon, Youth Services. He recounted some of the areas when Peg was of assistance to the Antrim Police Dept.

John Jones asked that a decision be delayed until more information is available. He would like to know the break down for payments from the State and the Town of Bennington for the second year.

The first year payment will be made by a grant from the State. Thereafter the State pays a portion of the expense. Chris was not sure if they would pay 1/2 or 3/4 of the cost. The remainder to be divided between Antrim and Bennington.

Chris mentioned his need for a secretary and was told to put it in the budget next year.

Mary Allen requested an executive session to discuss personnel.

Selectmen voted in favor .

Meeting called to order.

No decisions from the executive session.

Mary Allen asked the Selectmen to consider a new member and an alternate for the Board of Adjustment.

Lloyd is to be contacted to ask what progress if any is being made for the proposed Special Town Meeting. Proposed zoning changes, request for the transfer of money from the Capital Reserve fund to pay for the new cruiser, and a piece of property on Gregg Lake Road which Shaun Hickey wishes to buy are some of the issues which will go to a Special Town Meeting.

Lloyd is also to be consulted in regard to the status of the Public Service request for abatement of 1981 taxes. Lloyd has met with other attorneys from some of the other Towns which Public Service has requested abatements from.

The is still a question as to residence on the Lyman property off Gregg Lake Road. If children have enrolled in the Conval School district, the trailer on the property can no longer be considered a vehicle and therefore in violation

of the zoning regulations.

A question as to attending Antrim Schools while a house is actually in Hancock was raised. Who is paying school bill, Antrim or Hancock? This will be looked into.
