

SELECTMEN'S Minutes, Monday, November 28, 1988

Present: Rachel C. Reinstein, Chairman, Edwin F. Rowehl, William Suydam, Jr, Madeleine Henley, Administrative Assistant and Elizabeth M. Shaw, Secretary/Bookkeeper.

Meeting called to order at 7:30PM.

The scrap pile at the land fill will be removed starting on Wednesday.

Chris Joseph, Police Chief requested an executive session. So voted.

Meeting called to order. No information available from the executive session.

Art Stenberg, Zoning Inspector, returned permit #88006. Sam Harding, with the permission of the Selectmen, changed the set back on the proposed construction in order to meet set back requirements. Permit approved.

Art was given permit applications #88007 and #88008.

Sy Little and Harry Page discussed the Kincaid Construction permit for the storage shed on Water St. Since only three markers were located to check the lot lines on the property, Mr. Page plans to build using the most restrictive lot lines.

Rachel Reinstein asked about the two permits one of which was suspended and the second one being an approved permit for construction on the same property. Will Kincaid Construction withdraw the second permit if the Selectmen approve the permit for the duplex? Mr. Page did not give commit himself.

After much discussion, Selectmen approved the permit for the duplex.

The replacement on the shed on the same property was disapproved according to Article 13 Sec. DI.

Selectmen moved to revoke the previous permit now that the permit was issued for the duplex. Rachel Reinstein, Bill Suydam and Edwin Rowehl so voted.

Jane Hill, Health and Welfare Officer was asked to check State guidelines for rent assistance. She was also asked to check on eligibility and verify information on the application. It was also advised that all applicants should apply to Keene for assistance first since the town assistance is set up for emergency situations.

An intent to cut was signed.

Madeleine Henley informed Selectmen the time is up for the removal of the Hyland building. Selectmen approved the bid specs for removal and agreed to run an add in the Keene, Concord and Manchester papers.

Minutes of last weeks meeting approved with minor corrections.
