Selectmen's Meeting Wednesday, 10:00 am OCC FES CC Present, Rachel Reinstein, Edwin Rowehl, William Suydam, Jr., Madeleine Henley (aa), Shelley Nelkens, HazMat (Title III Committee) Kevin Ricupero spectator.

The meeting was called to instruct Shelley in the reporting requirements of official town business.

The meeting began with a summation of Madeleine's telephone conversation with Grace Walker; Ms. Walker says that she was misunderstood, that what is required of Antrim is a separate report, called an Emergency Response Plan, which includes an evacuation plan. Except for the evac plan, the Emergency Response Plan can be created entirely by reference to the Emergency Management Plan.

Then followed a discussion of the Title III Fact Sheet, at which time Shelley said she had that and was aware of the requirements of the EPA.

The discussion moved to the rumor that radiation training had been going on, Shelley said it was radiological training, and the final of the four classes was that evening. The Selectmen told her that they had not been informed of any training, Shelley said she had told Madeleine, Madeleine said she had not been told. It was resolved that Chris Joseph (Police Chief) had told Madeleine some time ago that there was talk of a training seminar sponsord by HazMat, and he didn't want this expense coming from his budget. Madeleine had told him at the time that Shelley had no authority to spend money, as she had no budget. Apparently, this was assumed by Shelley to be sufficient notification.

It was agreed by the Selectmen and Shelley that in the future, the Selectmen's Office will be notified of everything the HasMat committee does. In addition, Shelley will bring in a report of the past performance of the committee, along with minutes of all meetings which have been held. Also, Shelley listed several portions of the required plan which she could complete with information she currently had, and the Selectmen asked her to submit those portions.
