

Selectmen's Meeting, Monday, July 30, 1990

Present: William Suydam, Jr., Chairman, Edwin Rowehl, Donald Phelps, Madeleine Henley, AA and Betty Shaw, Secretary.

Meeting called to order at 7:30

Bill Suydam corrected last weeks minutes to show Chris had told the selectmen he was not present and could not second guess the officer involved in the complaint of noise from a wedding.

Don Phelps moved to accept the minutes with the above change. Second Bill Suydam. So moved.

Don Phelps moved to approve the minutes of July 16th. Second Bill Suydam, Ed Rowehl. All in favor. So moved.

Dick Atkinson resigned as Hazmat coordinator . Don Phelps offered a name of a person to contact to see if he is interested in filling the position. Bill Suydam second. Madeleine will make contact and set appointment if agreeable.

Don Phelps moved to go into executive session per 91A to discuss personnel.

Mike Clemens, police officer and Gary Gagnon, police sgt. joined the selectmen in executive session.

Meeting reconvened.

Sgt. Gary Gagnon will report to the selectmen on a weekly basis to keep the selectmen informed of the police departments' activities. Gary will be responsible for signing all invoices for payment and he will inventory all Chris' equipment when turned in.

Don Phelps moved to approve payment of six weeks vacation pay to resigning Police Chief Chris Joseph. Second Bill Suydam. So moved. (Payment to be made in a lump sum once all insurance paperwork is received from Chris.)

The Town Beach ordinance was reviewed. The first paragraph was changed from "the regulation of the Town Beach at Gregg Lake, including boat launch area," etc., to "the regulation of the Town Beach at Gregg Lake, which includes the beach area" etc.

#1. No litter or refuse of any nature shall be deposited or left "on the beach, on the parking lot, at the boat launch area", or in the waters of the lake, except in trash cans provided for the purposes, to no litter or refuse of any nature shall be deposited or left "at the Beach" etc.

#5. It shall be unlawful to undertake any conduct which shall be disorderly or endangers the safety and welfare of others using the "beach" changed to read, "and welfare of others using the Town Beach".

#7. No pets or other animals shall be allowed on the "beach", or in the water serviced by the "beach" to read, "Town Beach" or in the water serviced by the "Town Beach".

#10. No vehicles shall be allowed to stand overnight on "Town Property" to "Town Beach Property".

A request to use the former Post Office for an information night on the proposed use of Hawthorne College by Harry Page was refused. It was suggested he use the gym since using the Town Hall may make it appear the selectmen were sponsoring the proposal. There will be a ZBA hearing on the variance to allow the use of the property for which Harry proposes.

An add will be placed in the Union Leader and a local paper for a new police chief.

Bill Suydam moved to adjourn the meeting. Second Don Phelps. All in favor. So moved.

TOWN OF ANTRIM  
TOWN BEACH ORDINANCE

Pursuant to their authority under NH RSA 31:39 and 41:8 the Board of Selectmen of the Town of Antrim, at a duly called meeting, enacted the following ordinance for the regulation of the Town Beach at Gregg Lake, ~~including~~ boat launch area, parking lot and picnic area.


*(which includes the beach area,*


1. No litter or refuse of any nature shall be deposited or left ~~at~~ on the Beach, ~~on the parking lot, at the boat launch area,~~ or in the waters of the lake, except in trash cans provided for the purposes.
2. It shall be unlawful to block the boat launching ramp.
3. It shall be unlawful to damage, deface or destroy any structures, plant or natural feature of the Town property.
4. It shall be unlawful for any person to bathe or be present at the Town Beach unless such person is adequately garbed in a bathing suit or other clothing.
5. It shall be unlawful to undertake any conduct which shall be disorderly or endangers the safety and welfare of others using the beach. *Town Beach*
6. Intoxication and obscene or indecent acts are expressly prohibited.
7. No pets or other animals shall be allowed on the <sup>Town</sup> Beach or in the water serviced by the ~~beach.~~ *Town Beach,*
8. It shall be unlawful for any person to disobey an oral or written request from an agent of the Selectmen.
9. The Town Beach shall be closed between the hours of 10pm and 5am the following day. It shall be unlawful for any person to be on the beach, the parking area, the boat launch, or in the water serviced by the beach during these hours.
10. No vehicles shall be allowed to stand overnight on *Town Beach* Property. Camping is prohibited.


Any person found guilty of violating any part of the Ordinance herein set forth shall be deemed guilty of a violation as defined by New Hampshire Revised Statutes Annotated and subject to fines as provided therein.

(Note: This ordinance supercedes the Town Beach Ordinance adopted 1981.)
