

Selectmen's Meeting, Monday, August 13, 1990

Present: William Suydam, Chairman, Edwin Rowehl, Don Phelps, Madeleine Henley, AA & Betty Shaw, Secretary/Bookkeeper.

Meeting called to order at 7:30.

Walter Crane requested information as to what kind of coverage the Town wanted regarding animal control. After some discussion Walter Crane was sworn in as Animal Control Officer by Bill Suydam.

Mr. Crane is willing to come in on Monday evenings to give reports to the selectmen if the Selectmen wish. Selectmen may request monthly reports through the Police Department.

Phil Dwight met to discuss the hiring of a police chief. Mr. Dwight reminded the selectmen of the vote at town meeting that if a position became vacant, no one should be hired without a public hearing. Mr. Dwight pointed out this may be the time to cut the police force back to two men.

Don checked out the runoff from Meeting House Hill Road during the heavy rain this past week-end and found the runoff was going down Miltmore Road and the Rymes property not across Route 31.

Holly Green (588-2310) met to discuss filling the position vacated by Dick Atkerson as the Hazardous Materials coordinator. Since Holly writes rules for hazardous materials for the State Environmental Agency she is aware of the kind of work which would be required. Don Phelps moved to appoint Holly as the Hazardous Materials Coordinator, second, Ed Rowehl, all in favor. So moved.

Holly mentioned she is interested in a possible appointment to the Conservation Commission since Scott Bowden will be resigning. Madeleine suggested she attend some meetings of the Conservation Commission and return to see if she is interested.

Minutes of the week of Aug. 6 to show H&Z not R&Z as the contractor for the handicap ramp. Don moved to accept the minutes as corrected. Second, Ed Rowehl, all in favor, so moved.

Don moved to pay the bill from Dennis McKenney for the markers on the Hillsboro/Antrim town line, second Ed Rowehl, all in favor, so moved. A letter to Hillsboro requesting they pay half of the bill plus half of the recording fee of \$25.

Don moved to accept the bid for the waste oil heater, second, Ed Rowehl, all in favor. So moved.

Brenner Fuller (588-3201) met to discuss an appointment as alternate to the ZBA. Bill moved to appoint Brenner as an alternate. Second, Don, all in favor, so moved.

Bill Swore Mr. Fuller in.

Don moved to have the ^{roof} replaced. Include the flashing along the building if needed. Calls to be placed to other contractors for bids.

Second Ed, all in favor, so moved.

Don moved to accepted a drafted letter for setting dates on the ZBA alternates. Second Ed., all in favor, so moved.

Bill moved to adjourned, Second Ed Rowehl, all in favor. so moved. 9:35 ems
