Minutes Antrim Board of Selectmen Meeting

July 8, 1991

Meeting called to order at 7:30 P.M. by Chairman Edwin Rowehl

Attendance: Edwin Rowehl, Philip Dwight, and Donald Phelps

David Clukay, Town Auditor, regarding audit of Town books. He went over areas of concern noted in the audit and reviewed the financial standing of the Town as of December 31, 1990, which showed a funds balance of \$160,894. in the black of which \$103,174 is obligated to various wampered purpose.

Road Agent Robert Varnum and Police Sergeant Gary Gagnon joined the meeting at 7:45 P.M. to discuss the condition of Turner Hill Road, which has been damaged from logging. Bob estimates it will take 30 tons of asphalt to repair damages. Old English Logging did the damage. After discussion it was decided that the Town would investigate whether it was possible to collect for damages or to post roads to prevent future incidents.

Bob Varnum reviewed the Breezy Point Road Re: driveway issue raised by Mr. & Mrs. Roy. Bob felt the driveway drainage problem was most likely due to location of the abutting driveway rather than from the road and he did not feel it was possible to install a culvert under the driveway. The issue of the "Private Road" sign was also discussed and it was determined that Sgt. Gagnon should contact the appropriate Condo Association or the Developer and inform them that the sign should be removed.

Carlos Quintal joined the meeting at 8:10 to discuss Hawthorne renovation plans. He made a brief presentation of the plans and scheduled a meeting for July 22 at 8:00 P.M. to make a formal presentation.

Reviewed a letter from the Harris Center Re: River's Protection Management Advisory Committee Delegate. Discussed potential candidates with no decision made.

Shea Field Committee has not completed rewriting the Shea Field Lease.

- P. Dwight reported that through May, revenue from Motor Vehicle Registrations is down 8%.
- D. Phelps reported that the Great Brook Dam 9.06 will not be charged a fee in the future.
- P. Dwight moved to increase the Parks and Recreation Committee to seven (7) members and to ask the sitting members to submit names for new ones. Second D. Phelps. So Moved.

Reviewed property liability insurance policy and decided to ask department heads to review list for accuracy and completeness.

- P. Dwight moved to approve the minutes of July 1, 1991. Second E. Rowehl. So moved.
- E. Rowehl brought forth a note from Mr. Hardwick Re: Fire Alarm. Ed will check with the Fire Chief to see if they have determined whether it is possible to cut back the length and number of blasts.
- D. Phelps moved to adjourn. Second P. Dwight. Meeting adjourned at 9:15 P.M.
