Phil moved to hire Cameron as a Special Officer for the Town. Second Dave. All in favor. So moved. Cameron was sworn in as a Special Police Officer.

Brian has received cost figures to convert the antenna on the Town Hall and make it possible to keep in contact with dispatch. The total cost will be \$365. The Town of Bennington will share the expense of the conversion. There will also be an added cost for a direct telephone line which Bennington will also share the cost. The change will enable both Towns better contact with the dispatch.

Pat Beers, Gene and Woody Woodworth, Pat Webber, Bob Bagloe, Bob Holmes, Bonnie DeBrino, Cindi Gelardi, members of the Parks and Recreation joined the meeting to discuss the problem with the liability insurance. Selectmen explained that the Town coverage protects the Town but it does not cover a private organization such as the Friends of the Parks and Recreation. The Selectmen gave the Friends of the Parks and Recreation permission to use the Town Gym, but the Town can not protect the organization in the event there is a liability claim.

It was reported at this time that the Gym is not being properly maintained by the School. There are broken windows, the ceiling tiles are falling down and wind is blowing into the building by the cracks under the door.

Pat Beers reviewed the warrant for repairs to the tennis court and the basketball court.

Phil moved to accept the minutes of Jan. 27 as written. Second, Dave. All in favor. So moved.

Dave moved to have a hearing on changing the elderly exemption to the adjusted elderly. Hearing will be scheduled for Feb. 17 at 7:00 PM.

Selectmen went over the warrant for the Town Report.

Dave moved to adjourn the meeting at 10:27, second, Phil. All in favor. So moved.
