Minutes of the November 14, 1994 meeting.

Selectmen present were: Phil Dwight, Dave Boule and Tom Davis.

Also present was Police Chief Brian Brown.

The meeting was called to order at 7:00 p.m.

Dave moved to accept the minutes of the November 7, 1994 meeting as written. Tom seconded the motion - all were in favor.

Chief Brown presented the Selectmen with the resignation of Mark Cavic. He will be moving to the Chicago area to take a new job outside of police work. The resignation was accepted with regret and the realization that the Town was losing an effective and hard working officer. He will be missed. Chief Brown was authorized to immediately look for a replacement.

Upon duly made motions the following items were approved and/or signed  $\boldsymbol{\mathsf{-}}$ 

1. Abatements: James Rymes - Aiken House \$2,356.81 abated as per agreement

A group of property owners (see attached list) for properties erroneously taxed on right of way \$2,639.76

- 2. Warrant for Collection of Yield Taxes for Maria LoVerme in the amount of \$1,460.60
- 3. The Tax Collector's deed for Robert K. Roche's property was signed.
- 4. The Land Use Change Tax Lien Release in the name of Michelle Rabideau was reviewed and a new value set on the land of \$12,750.

Items discussed and resolved were as follows:

1. Gregg Lake Road Bridge - The Caron Bridge Report was reviewed and the preliminary feeling was that the bridge become " one way". Dave was to discuss this with Planning Board and suggest the current bridge be replaced by a culvert.

- It was decided to review tax abatement requests as they are received.
- 3. The Board will get estimates to "upgrade" the Town Report to include photographs.
- 4. Dave Cutter would be asked to provide the Town with a deed for "Post Road."
- 5. Street names and number questions were addressed. It was resolved that the name "Old Turnpike Road" was correct.
- 6. The Report form N.H.M.A./P.L.I.T. re: an "unsafe" situation was discussed and was to be sent to the Fire Chief for his recommendations.
- 7. Bart Mayer was to be authorized to attempt to settle the 1993 Tax abatement case "Robinson v Town of Antrim" at an agreed upon dollar amount.
