Minutes of the December 12, 1994 meeting.

Selectmen present were: Dave Boule, Tom Davis and Phil Dwight.

A statement regarding Maruzen Hawthorne as a proposed prison site was drafted to release to newspapers.

Minutes of the December 5th and 6th Selectmen's meeting were approved as written.

The Selectmen confirmed the use of the name *Old Turnpike Road*.

The request from the *Estate of Elisha Grant* property requesting postponing monthly payments in lieu of tax deed until February was granted.

It was decided to study the possibility of offering **BLUE CHOICE** as an optional Health insurance program.

Abatement requests in the name of:

1. Mark E. Reynolds was approved reducing the house value from \$84,800 to \$71,700.
2. Martha E. Brown was approved reducing the house value from \$23,300 to \$15,000.
3. Adrienne D'Amelio was denied.
4. Anthony D'Amelio was denied.
5. Lucy and Raymond Gregoire's will need to supply more information before a decision can be made.
6. New England Timber Realty, Inc. will be provided with a formal abatement application form.

It was agreed that the Town would assume responsibility for approximately 100 yards of Lovern Mills Road beginning at the current end of the Class 5 road to the foot of the Gregoire driveway. The Gregoire's would be required to pay, next summer, for the gravel needed to top the section so it can be properly graded.

- Notice of Zoning Violation in the name of Andrew and Gail Demasi for a Hazardous Condition of House.

The Antrim Selectmen were informed late last week that Maruzen Hawthorne would be proposed as one of four sites to expand the New Hampshire State Prison system. Mr. Mark Corrigan, hired by a Joint Committee of the legislature to develop such a plan, outlined very briefly what his presentation to the legislative committee would contain, but pointed out that the final report would not be ready until January.

There are obviously many concerns and questions that must be addressed before a response to the proposal is determined, the first and foremost being what effect such a use would have on the safety of the residents of the Town.

While a prison facility is not what anyone would consider to be the optimal use of the campus we trust that we will have time to gather all the information necessary to make an informed judgement as to whether or not to oppose this plan.
