Minutes of the March 27, 1995 meeting.

Selectmen present were: Paula Kulpinski, Tom Davis and Peter Moore.

Also present was Phil Dwight and Bill Weston.

Mr. Weston informed the Board of his intentions of improving access to one of his lots near Willard Pond. He indicated he would be trucking a minimum amount of gravel from his own land. He also indicated Park Construction might be purchasing gravel from the same area. If so, that company would obtain the necessary permits.

Minutes of the Meeting of March 20 were approved.

The Board reviewed the fee for the building permit for Mr. Nastasi and established the areas to be charged for. Phil is to obtain building permit schedules from area towns.

Mike Beauchamp's request to be paid for time at a seminar in June was approved to be reimbursed at the normal fireman's rate.

Mrs. Lee's conversation with each of the Selectmen about their property on Old Pound Road was discussed. Paula will call Mrs. Lee and indicate that Bob Varnum will attempt to correct the water run off situation.
