

Antrim Board of Selectmen  
Minutes of the April 3, 1995 meeting.

Selectmen present were: Tom Davis, Paula Kulpinski, Peter Moore.

Also present was Phil Dwight.

The meeting opened at 7:00 p.m.

The Minutes of the meeting of March 30 were approved with one correction. The reference to "Mental Health" in paragraph 3 page 2 should have been "Family Health."

The Board reviewed the letters from Town Counsel and approved the settlement as provided in his letter of March 27.

The Letter of Agreement between the Town and Swiftwater Girl Scout Council re: the bridge and causeway on Gregg Lake Road was approved and signed.

The individuals on the attached list were formally appointed to the "Aiken" Committee.

Appointments to the Z.B.A. were discussed.

The Board reviewed the first quarter financial statements. Phil pointed out that there appeared to be no concerns and that expenses were within budget. Summary reports were to be provided monthly in the future and detailed reports on a quarterly basis.

Paula indicated that she would review the Cuddihy correspondence re: the name of Brimstone Corner Road.

The request for waiver of fee for the use of the Town Gym by New Hampshire Dance Institute was discussed. It was agreed that 1/2 the fee would be waived. It was also asked that procedures be reviewed so such request were received at least two weeks prior to the planned event.
