Minutes of the April 24, 1995 meeting.

Selectmen present were: Tom Davis, Peter Moore and Paula Kulpinski. Also present was Business Manager Phil Dwight. Mrs. Emmett Lee was also present.

Mrs. Lee attended the meeting to discuss her concerns about her well and road damage at her property on Old Pound Road. She presented the Board with an analysis by New Hampshire Department of Environmental Services of the well water. The Board indicated they would review the situation and provide a written answer to her within three weeks.

Road Agent Bob Varnum is to be asked to review the drainage on Mrs. Lee 's property and the Board would like to meet with Bob on May 1 to discuss this situation.

The Board opened seven sealed bids for the 1950 Farmall Tractor with sickle bar. The tractor was sold to Clark Craig the highest bidder at \$877.50
