The Selectmen met with Paul Belliveau and Road Agent Bob Varnum to discuss possible changes to the High Street Bridge. It was suggested to add a 3 - 4 foot pre-stressed decking that is independent of the bridge and re-anchor the post. After a brief discussion it was the consensus of the Board and Mr. Varnum to contact Henniker Sand & Gravel to have someone come out and view the bridge to see what he or she can suggest.
