#### 6:00 p.m. MEETING CALLED TO ORDER -

#### 6:00 p.m. meet with Police Chief Brian Brown -

Chief Brown met with the Selectmen to inquire if he could take \$900.00 out of his general supplies to paint and stencil the Crown Victoria Police Cruiser black to match the new Expedition. The Selectmen reviewed Chief Brown's current budget and decided that there was enough money in his budget and unanimously agreed.

#### Aiken House Bid -

Bruce Armer will review the plans and specs for the Aiken House Project to see if the amount comes closer to the bid of \$530,000 or the remaining amount from the grant of \$315,000.

#### Town Hall Bid -

The invitation to bid will be advertised on Wednesday and Thursday (7/12 & 7/13). The bid will be opened on August 11, 2000.

#### Home Rule -

The Selectmen signed the Home Rule resolution and agreed to contribute \$250.00.

#### Hazardous Waste Day -

The Selectmen supported holding a Hazardous Waste Day in Bennington on October 14, 2000.

#### Telecommunication Tower –

The Planning Board will be sending out a bulk mailing in August notifying voters of the proposed zoning change and special town meeting on September 12, 2000.

#### Conval payment schedule -

The Selectmen reviewed the payment schedule for the school payments, Selectman Dwight noted that it has increased by \$300,000 which would effect the tax rate by about \$3.00.
