PRESENT: Eric Tenney, Chairman, Selectman Tim Seeger, Selectman Phil Dwight and Secretary Sherry Miller.

#### 6:00 P.M. MEETING CALLED TO ORDER -

## 6:00 P.M. Mr. Steiner from NHMA Re: Insurance for volunteers -

Mr. Steiner spoke with the Selectmen regarding who was covered by the Town's insurance. Mr. Steiner stated that anyone who is recognized by the town as a volunteer would be covered under the insurance, so long as the individual is working within their scope of duties.

Mr. Steiner stated that even though Fire and Ambulance personnel are considered "Volunteers" they are also considered employees of the town and are covered under workers compensation.

If a volunteer was injured and <u>did not</u> have medical insurance, the New Hampshire Municipal Association would pay up to \$10,000.00 for medical bills. If the individual did have medical insurance their insurance would be billed and the Association would pay up to \$10,000.00 in deductibles.

There was a brief discussion as to how a Firemen's Lady Auxiliary could be covered by the Association. Mr. Steiner stated that it is very difficult to provide coverage for such groups. Mr. Steiner stated that he would speak with the Associations Attorney and get back to us with some alternatives.

#### Hillsborough County Budget -

Selectman Dwight stated that the Hillsborough County budget has been approved. Selectman Dwight stated that we would need to raise about 10 % more in taxes.

#### Copier Lease -

Selectman Dwight stated that the lease on the copy machine will end within the next two months. After looking into purchasing another copy machine Selectman Dwight found that for an additional \$40.00 a month we can turn in the old machine for a new one that has two added features (two sided copies and a 10 bin sorter) the total cost of the new machine will be \$146.50 per month which includes a service contract. The Selectmen unanimously agreed to purchase a new copy machine.
