**6:00 p.m.** Police Chief Brian Brown was scheduled to meet with the Selectmen to discuss his proposed 2001 budget, Chief Brown was delayed and needed to reschedule he will meet with the Selectmen on October 23 at 7:00 p.m.

**Miscellaneous items signed –**

The Selectmen signed a TAN for \$150,000, the 2000 Presidential Warrant and an Abatement.

**Deering/Antrim Bridge –**

The Selectmen briefly discussed the Deering/Antrim Bridge. It was decided that we will ask Bob Varnum to speak with the Deering Road Agent, Peter Beard to ask what their opinions are.

**Items reviewed –**

The Selectmen reviewed a Dredge and Fill application received from Danielle Noble.

The Selectmen reviewed a letter from the Department of Revenue Administration regarding a Supreme Court ruling stating that the statutory alternative lien procedure under RSA 80:58-87 is unconstitutional. The New Hampshire Attorney General's office has filed a motion for reconsideration of the Court's decision.

A letter from the Town of Bennington regarding the landfill was reviewed. The Selectmen are scheduled to meet with the Bennington Selectmen on Wednesday October 18 at 6:00 p.m. they will discuss the letter further at this meeting.

The Town of Peterborough has sent us information about obtaining replicas of the Boston Post Cane. The Selectmen decided that they would try and make contact with the last known recipient of the Boston Post Cane, if we are unable to locate the cane we'll order two, if the cane is found we'll only order one as the cost is rather expensive at \$265.00 each.

The Selectmen reviewed rates received from AFLAC, which offers supplemental insurance. It was decided that we will talk with Brian and Bob to see if they think their employees would be interested.

**Review and approve the October 2, 2000 minutes –**


The Selectmen unanimously approved the minutes of October 2, 2000.
