TOWN OF ANTRIM BOARD OF SELECTMEN'S MEETING MINUTES DECEMBER 11, 2000

PRESENT: Chairman Eric Tenney, Selectman Tim Seeger and Selectman Phil Dwight.

6:00 p.m. MEETING CALLED TO ORDER -

6:00 p.m. Met with Police Chief Brian Brown -

Police Chief Brian Brown reported that he had received 15 applications for the open Police Office position. Only two were certified officers and one had not been involved in police work for a few years. He had talked with the other individual and felt the Board should schedule an interview. This will be at 6:00 p.m. December 18, 2000. A tentative salary was discussed and authorized by the Board.

The Samaritans -

The Selectmen reviewed a letter received requesting a donation of \$250.00 after a brief discussion the board decided not to contribute this year.

Upton, Sanders & Smith -

The Selectmen reviewed a letter received from Upton, Sanders & Smith regarding Impact Fees/Zoning Amendment Proposal. The original letter was sent to the Planning board as this is their jurisdiction.

Equalized Assessment Sheet -

The Board reviewed and signed the Equalized Assessment Sheet as required by the D.R.A. It was noted that there probably would be a significant change in the Town's equalized valuation and ratio as a result of the real estate sales in the past year. Sale prices for the most part, were considerably higher than assessed value with the difference even greater for more expensive properties. For instance, properties (house and land) whose assessed value was over \$90,000, sold, on average, for 39% more than their assessed value, while property assessed for under \$90,000 sold for about 29% higher.

Unexpended Warrants -

The Selectmen voted unanimously to carry forward balances in the designated funds for Memorial Park and the Bandstand (Antrim in the Evening).

General Government Budget –

A tentative town budget was established which will be presented at a public meeting on January 8, 2001 at 7:00 p.m. to be held at the Maplehurst Inn. This tentative budget is attached to these minutes.

BASED ON THIS PROPOSED BUDGET, THE TOWN TAX RATE WOULD INCREASE BY ABOUT \$1.22, OR 11%.

PLEASE NOTE, HOWEVER, THAT THE INCREASE IN DEBT SERVICE COSTS ARE MORE THAN THE ENTIRE INCREASE. IN OTHER WORDS THE REST OF THE BUDGET IS DOWN ABOUT \$30,000.

NOTES TO PROPOSED 2001 ANTRIM BUDGET

- 1. Salary budget down \$17,000
- 2. Medical premium costs up 9.3%.
- 3. \$4,000 estimated increase in oil costs.
- 4. \$5,500 cost of updating tax maps no longer needed.
- 5. \$3,000 computer software; \$1,000 each for gas, supplies and misc. Pay increases.
- 6. \$3,000 each for line-striper & manhole cover replacement; \$6,000 extra for gravel, but no add'l warrent; pay increases.
- 7. \$5,500 salaries for add'l employee on Saturdays: \$10,000 for add'l waste disposal costs resulting from credits used in 2000.
- 8. New programs proposed
- 9. Town Hall bond payment of \$134,000: Aiken barn \$14,000
- 10. Increases are \$10,000 for Ambulance; \$2,500 for police cruiser; \$6,500 for bridge fund
- 11. Only monied warrent article at this time is for pay increase for Town Clerk/Tax Collector.
