APRIL 2, 2001**

PRESENT: Chairman Eric Tenney, Selectman Phil Dwight, Selectman Dave Penny and Sherry Miller.

6:00 p.m. MEETING CALLED TO ORDER –

6:00 p.m. Brian Brown –

The Selectmen met with Brian Brown to discuss what's happening within his department. Brian stated that everything is going fine. Brian did state that he had recently discovered that there are three children attending A.E.S., although they reside in the Town of Hillsborough. Selectman Dwight notified the SAU of the situation and they will be handling it. Selectman Dwight suggested that we send a letter to the SAU and request that in the future if they have any suspicions regarding a student's residency that they formally contact the Selectmen so they can determine the proper course of action.

Ratio –

The Selectmen reviewed the letter sent to the DRA by selectman Dwight regarding a request for a review of the Town's Sales Assessment Ratio.

Bennington Infiltration Basin –

FYI – regarding the need to construct a drainage lagoon at the excavation site in Bennington. Bill Reid has accepted an offer to view the area in the spring/summer with the Road Agents and selectmen.

MCT Maintenance Agreement –

At their last meeting the Selectmen decided against signing a maintenance agreement with MCT telecom, however in the days to follow the meeting the Selectmen received information that was not previously available. After reviewing this information the Selectmen unanimously agreed to sign a maintenance agreement with MCT for the maintenance and repair of the office phone system.

Approval to repair stair tower –

The Fire Chief submitted an estimate to repair the stair tower at the company # 1 station. The Selectmen were unsure as to what stair tower was in need of repair. A call will be made to Chief Beauchamp for clarification.

Steels Pond Hydro Payment/Invoices –

The town has received a check for \$17,346.75 in lieu of taxes from Steels Pond Hydro. This represents a 4% payment under the Steels Pond Pilot Agreement.

Abatement –

The selectmen reviewed a request from Antrim Mill Corporation for an abatement for property located on Depot Street. After a brief discussion and review of similar properties the Selectmen unanimously agreed to reduce the land value to \$19,900.

Donation request –

The Selectmen unanimously approved a \$40.00 donation to the Contoocook-North Branch River Advisory Committee.


No decisions were made while in non-public session.
