The Selectmen met with Kristin Vance, Director of the Grapevine to discuss the Grapevine using the former Town Office space. They are intending to use the front part for office use and the back portion would be used for storage. Selectman Dwight stated that there are still things over there that can't be moved until the paving is complete. It was also pointed out that Public Service and Rymes would be notified to send all future bills to the Grapevine. Selectman Dwight will meet with Kristin on Thursday, August 9 to go through the office to determine what items will go up for sale at the Grapevines yard sale on Sunday, August 12th.

Open House -

The Selectmen agreed to hold the Town Hall open house on Saturday, September 15th.

Public Hearing -

The Selectmen unanimously agreed to hold a public hearing on Monday, August 20, 2001 at 6:30 p.m. to take action on money received from FEMA.

Fire Department -

The Selectmen unanimously approved the serving of alcohol at the Fire Station (Company #1) on Sunday, August 11th for the annual muster.

Town Hall Status (upstairs) -

The upstairs received the first coat of urethane on August 6th, the second coat won't be able to go on until Thursday due to the final walk through being scheduled for Wednesday, August 8. Its hoped that the final coat can be applied Friday or Saturday and usable either Sunday or Monday.

7-month expense report -

The 7-month expense report was reviewed. The Selectmen will set up times with the Highway and Police Department to go over their status.
