This status allows Boards, committee or commissions member duties, to contact with Town departments over which they have no jurisdiction, without there being a conflict of interest problem.

### B) LETTERS TO SENATOR BREWER AND REPRESENTATIVE RICE

Communication to Senator Brewer and Representative Rice to bring to their attention the Towns serious challenges to maintaining its road, sidewalks, bridges and dam and infrastructure, because of devastating damages from the weather to the roads and the lack of voter approval of funds needed. The letter conveyed the desperate need of revenue for the Town with which to maintain its public ways
