This land was formerly used as open space, and currently used for the same purpose. If acquired by the Commonwealth the land will be used as open space for conservation and recreation purposes and shall be incorporated into the state system of parks, reservation and forests. The property abuts the Ashburnham State Forest and is shown on the enclosed locus map marked “Exhibit A”.”
