
On behalf of Dave Caruso of 107 Fitchburg Road, Northland Engineers respectfully request an approval under the provision of 310CMR15.405:1(h) for a one foot reduction in the 4 foot offset to estimated season high water.

This lot has a failing leaching field near the roadway, due to very high water. Test was conducted behind the house, at an area 100' from the existing well, where the soils are rocky and have a steep slope all the way to the rear lot line. A design on this slope,, and in compliance with the state code will require cascading fill a long way down hill, at great expense to the new owner.

We respectfully request the Board allow the one foot reduction in this offset to estimated seasonal high water, to a three foot offset. This will reduce the cost of the repair of this leaching field, for this dwelling of low value.
