BOARD OF SELECTMEN MINUTES

MONDAY, NOVEMBER 3, 2014 – 6:30 P.M. TRAINING ROOM AT PUBLIC SAFETY BUILDING

This meeting is aired live and taped for local television.

PRESENT: Leo Janssens II, Chair, Duncan Phyfe, Member, and Doug Briggs, Town Administrator. Nick Davis and Sylvia Turcotte were not present.

I. SALUTE THE FLAG

Leo Janssens called the meeting to order at 6:30 p.m. and led everyone in the Pledge of Allegiance.

II. SOLICIT PUBLIC INPUT (5 minutes limit)

Jeff Lindquist from Camp Winnekeag came to ask the proper procedure for putting an article on a town meeting; Doug Briggs stated that for a special town meeting they would need 100 certified registered signatures and for the annual 10 certified registered. He stated that taxes were delinquent on the dam and he asked if the Town would want to take ownership. Selectman Janssens stated that due to the liabilities that come with owning the dam; the town is not interested we already have five. Mr. Lindquist also inquired as to whether the town was a part of a water shed district much like they have in Leicester MA. which could allow the owner of the dam to levy a fee on the lake residents as opposed to having a Lake Association. Mr. Briggs will look into the pros and cons of this type of classification.

III. APPROVAL OF AGENDA

Duncan Phyfe made the motion to approve the agenda as presented and was seconded by Leo Janssens. Motion carried.

V. OLD BUSINESS

A. Review of Special Town Meeting held on Tuesday, October 28, 2014

Duncan Phyfe stated that some resident were asking about the mailing of the warrant to residents which is costly and asked if Code Red could be used as an alternative to notify voters of Town Meetings in the future and Mr. Briggs stated that it could be done as we have used it in the past.

Doug Briggs stated that the meeting went very well, about an hour. He noted that Article 8 was the Citizens Petition regarding the Tennessee Gas Pipeline and that the Town has already complied with number 1 listed in this petition, by sending letters to our legislators and number 3 with the letter from the Board of Selectmen the "Recission of Survey Permission" dated April 7,

2014. He also stated that Sylvia has incorporated a folder on the town's website home page where residents can view all the information that the town has received regarding this subject.

VI. NEW BUSINESS

A. Review and Approval of the 250th Celebration Committee's Invitation to the Opening of the Ashburnham Century Box

Duncan Phyfe made the motion to approve the invitation as presented and was seconded by Leo Janssens. Motion carried.

VII. TOWN ADMINISTRATOR'S REPORT

Doug Briggs began by listing the openings on Boards and Committees with the Zoning Board of Appeals in desperate need of new members.

He stated that the Water Main replacement is complete on Turnpike Road and that road repairs will begin in the spring after the thaw.

He noted that due to weather conditions, the road work on E. Rindge Road to Young Road was delayed but should be done tomorrow, Tuesday, November 4th and will take only a few days to complete.

He stated that Comcast has responded to our RFP and both Ashburnham and Westminster in conjunction with our lawyer Bill Solomon are in negotiations with them. He added that the negotiations are progressing and that they met on Friday, October 31st.

Mr. Briggs stated that the Fire Union negotiations will begin again on November 12th.

He stated that Kinder Morgan will hold an Open House discussion on the Gas Pipeline at Oakmont Regional High School in the Auditorium on Thursday, November 20th from 6:00 to 8:00 p.m. He added that Sylvia has added a special section on the Town's website home page where up to date information has been placed to keep the general population informed.

He stated that together with Westminster and the School District, we sent out an RFP for health care insurance coverage. He noted that initial indicators show an increase of about 11.8% but we are still negotiating as well as looking at other coverage options. He added that due to the time constraints, we will need to move forward as the insurance year begins on January 1st.

Mr. Briggs stated that the cameras at Winchester Park have been changed and are now operational. A new LED lighting fixture will be added to improve monitoring capability. A motion light will also be put in the gazebo as an added option.

He noted that the School District received word that they have been awarded a grant in the amount of \$350,000 towards the conversion of the oil heating system to biomass pellet boilers at the Overlook Middle School.

He stated that the Board of Selectmen has been asked to vote to revise the current rate of compensation for participants in the Senior Work-Off Program from its present rate of \$7.50 an hour to the present state minimum wage of \$8.00 an hour. He noted that they would also authorize the current cap rate of \$750 exemption to a new rate of \$1,000 with total volunteer hours of 125. He added that currently we have two seniors in the program. *Duncan Phyfe motioned to approve the changes as noted and was seconded by Leo Janssens. Motion carried.*
