BOARD OF SELECTMEN MEETING MINUTES

MONDAY, DECEMBER 21, 2015 – 6:30 P.M. TRAINING ROOM – PUBLIC SAFETY BUILDING

This meeting was aired live and taped for local television.

PRESENT: Leo Janssens II, Member, Kyle Johnson, Clerk, Doug Briggs, Town Administrator, and Sylvia Turcotte, Executive Assistant. Duncan Phyfe was not in attendance.

I. SALUTE THE FLAG

Leo Janssens called the meeting to order at 6:30 p.m. and led everyone in the Pledge of Allegiance.

Leo Janssens made the motion to approve the list of license renewals as read and was seconded by Kyle Johnson. Motion carried.

C. Review of the December 11, 2015 Tree Lighting and Santa Parade

Kyle Johnson noted that it was his first time attending this event and he found it to be a tremendous success and the crowd was great. He stated that the Parks & Rec Committee did a great job and that the Town needs more of these events. Leo Janssens stated that the crowd was huge and all in a good festive mood. He noted that cars were parked down Central Street and the Committee does an outstanding job along with the Fire Department. Doug Briggs added that all the departments worked together, the Light, Fire, Police and DPW. He added that his grandkids enjoyed it very much.

VII. TOWN ADMINISTRATOR'S UPDATE

Doug Briggs stated that they are meeting with the MA DOT tomorrow regarding the intersection issue. He stated that if MA DOT goes forward with their plan the Town would have to take 10 land takings, appraisals for each taking as well as the cost for eminent domain. He stated that they would have to determine if it would benefit the Town.

He stated that the FY17 budgets are all in now and that he would be scheduling reviews with the Department Heads after the first of the new year. He added that he was very impressed with the Department Heads for submitting budgets that were realistic. He stated that he would be meeting with the Department Heads to review the Capital Plan, including dams. He noted that one of the challenges this year is the health insurance cost which went up by 11.5% which he is hoping they can lower in July.

Mr. Briggs stated that the Energy Committee is moving along with the Library project as well as the Public Safety Building LED lights project which was through the grant at a cost of \$15,000 for the new bulbs. He stated that Phase II would be the outside lights and that they were looking at a couple of LED lights for Town Hall as well.

He stated that through Ed Vitone's hard work they were able to put out an RFP for insulation at the Library and he thanked Ed for his efforts. He added that January 5th a walk-through is scheduled and the bids are due on January 20th. He noted that once this is done, they would be

looking at the heating system requirements. He added that Mr. Vitone and Mark Carlisle met with Leo Janssens to look at the current system and to decide whether to replace with one or two units. He stated that with the savings they are hoping to take out the 300 gallon tank in the ground and replace it with two smaller tanks like the ones at Town Hall. He added that they will also work to replace the light fixtures. He noted that if other projects come up more money is available.
