JOINT MEETING BOARD OF SELECTMEN AND ADVISORY BOARD MINUTES monday, april 6, 2015 - 6:30 p.m. training room at public safety building

This meeting was aired live and taped for local television.

PRESENT: Leo Janssens II, Chair, Duncan Phyfe, Member, Nick Davis, Clerk, Doug Briggs, Town Administrator, and Sylvia Turcotte, Executive Assistant.

Advisory Board members present were: Bill Johnson, Chair, Bruce Whitney, Allison Weissensee, Ron Putnam, Jaime Piedrafite and Gail Dumont. Joe Oliveira was not in attendance.

I. SALUTE THE FLAG

Leo Janssens called the meeting to order at 6:30 p.m. and led everyone in the Pledge of Allegiance.

- II. SOLICIT PUBLIC INPUT (5 minutes limit)Joe Benavidez of the Gardner News advised that he was taping the meeting.
- III. APPROVAL OF AGENDA

Duncan Phyfe made the motion to approve the agenda as presented and was seconded by Nick Davis. Motion carried.

- IV. PRESENTATIONS & REPORTS
- V. OLD BUSINESS
 - A. <u>Review of the Easter Egg Hunt held on Saturday, March 28th in the Gym at Oakmont</u> Leo Janssens read that Steve Coswell, Chair of the 250th Committee stated that the event was very well attended with many children enjoying the activities.
- VI. NEW BUSINESS
 - A. <u>Approval of the Town Election Warrant for Posting</u> Nick Davis read the posting as follows:

"Greetings.

In the name of the Commonwealth of Massachusetts you are hereby directed to notify and warn the inhabitants of said Town who are qualified to vote in elections and in Town affairs to meet in the John R. Briggs Elementary School Gym, 96 Williams Road, Ashburnham.

WARRANT 2015 – 2016 Tuesday the 28th of April 2015 At 9:00 a.m. until 8:00 p.m. To bring in their ballots for: One Moderator – For one year term One Board of Selectmen – For three year term One Board of Selectmen – For one year term Two Board of Health – For three year term One Planning Board – For five year term Two Library Trustees – For three year term One Municipal Light Board – For three year term One Ashburnham School Committee – For three year term

One Westminster School Committee - For three year term

Hereof fail not and make return of this warrant with your doings thereon at the time and place of said meeting."

Duncan Phyfe motioned to approve the posting and Nick Davis seconded. Motion carried.

B. <u>"Purple Heart Town" Proclamation</u>

Leo Janssens stated that we received a request on March 17th from Leo David Agnew, the Department Commander Massachusetts Military Order of the Purple Heart, Combat Wounded. He is requesting that a proclamation be drafted by the Selectmen honoring all veterans who have made the ultimate sacrifice and shed their blood in all wars from Ashburnham. Nick Davis read the proclamation as follows:

"**WHEREAS**, the people of the Town of Ashburnham have great admiration and the utmost gratitude for all the men and women who have selflessly served their country and this community in the Armed Forces for the good of all; and

WHEREAS, contributions and sacrifices of the men and women from Ashburnham who served in harm's way in the Armed Forces have been vital in maintaining the freedom and the way of life enjoyed by our citizens; and

WHEREAS, citizens of our community have been killed in action while serving in the Armed Forces and have been posthumously awarded the Purple Heart for their ultimate sacrifice; and

WHEREAS, citizens of our community have been awarded the Purple Heart for their bodily sacrifice of being wounded in action while engaged in combat; and

WHEREAS, the Purple Heart is the oldest American military decoration in present use and was created as the Badge of Military Merit on August 7, 1782 in Newburgh, New York by General George Washington. Initially it was made of purple cloth, shaped as a heart with the word "Merit" sewn upon it; and

WHEREAS, the heritage it represents is sacred to those who know the price paid to wear the Purple Heart; and

WHEREAS, August 7^{th} is nationally recognized as Purple Heart Appreciation Day; and

NOW THEREFORE BE IT PROCLAIMED, We, the Ashburnham Board of Selectmen, on behalf of the Town of Ashburnham, go on record to hereby proclaim Ashburnham Massachusetts a Purple Heart Town, honoring the service and sacrifice of our nation's men and women in uniform that were wounded or killed by the enemy while serving to protect the freedoms enjoyed by all Americans.

ALSO, BE IT PROCLAIMED, We the Town of Ashburnham will recognize August 7th annually as Purple Heart Day, and urge the people and organizations of Ashburnham to display the American Flag as well as other public expressions of recognition of our Purple Heart recipients.

IN WITNESS WHEREOF, we have hereunto set our hands and caused the official seal of the Town of Ashburnham, Massachusetts to be affixed."

Nick Davis made the motion to approve this proclamation and was seconded by Duncan Phyfe. Motion carried.

C. Approval of letter to Rep. Zlotnik regarding Local Veterans Agents.

Leo Janssens read the letter as follows:

"Dear Representative Zlotnik:

We are writing to urge your opposition to HD1590, "An Act relative to Veteran's Agents". Currently, Massachusetts Veterans are well served and cared for by Local Veterans' Agents.

House Docket 1590 will essentially remove the accountable local Veterans Agent; the cornerstone of the Veterans Services Program. Also lost, will be the ability to manage cases in the community, get veterans up to use the VA Healthcare System, get their physical and mental health checked, help get them back to work and reintegrated into the community.

Although on the surface, this proposal appears to financially benefit municipalities, it will not provide benefit without case management at the local level. Local care for Veterans most certainly will decrease, in conjunction with an overall cost increase at the state level, ultimately resulting in decreased local aid. Less service at a higher cost makes no sense.

We respectfully request that you closely read HD1590, considering the unintended consequences before supporting this type of legislation. This proposed bill is not in the best interest of our Veterans, dependents, and Gold Star Families and flies in the face of Massachusetts long-standing tradition of caring for our Veterans locally."

Duncan Phyfe motioned to submit the letter as read and was seconded by Nick Davis. Motion carried.

D. <u>Review and approval of the Annual Town Meeting Warrant Articles</u>

Leo Janssens stated that he would start with the Consent Agenda which was the first 8 articles on the warrant. He read each one as follows:

- Article 1. Accept reports of Town Officers and Committees
- Article 2. Light Department PILOT payment
- Article 3. Tax Anticipation Note Authority for Treasurer
- Article 4. Authority for Town Administrator to Contract with Mass. Highway
- Article 5. Authority to expend Ch. 90 Road Repair Money
- Article 6. Transfer of Cushing Academy Trust Fund Income
- Article 7. Transfer Title V receipts to pay principal and interest on septic loans
- Article 8. Offset receipt account for Waterways Improvement Fund

Mr. Janssens then asked for a motion to approve these articles and to support and recommend. *Duncan Phyfe made the motion and was seconded by Nick Davis. Motion carried.*

Leo Janssens then read Article 9: "To see if the Town will vote to raise and appropriate or appropriate by transfer from available funds such sums of money as may be necessary to defray the expenses of the Town for the fiscal year commencing July 1, 2015 and to set the salaries of elected officials." He read each line in the TA recommended budget for FY16 as follows:

- a. Town Moderator: \$100
- b. Board of Selectmen: Chairman \$1,300; Clerk \$1,100; Member \$1,100
- c. Board of Health: \$140 per member

Mr. Janssens questioned the FY16 budget lines that were lower than the FY15 numbers and Doug Briggs explained that it was due to the recommendation of the auditors to not have "indirect costs" but to have them pay out of their budget directly. He stated that this would impact some budgets such as the Town Administrator, Accountant, Treasurer etc. by a percentage of their work for the Light, Sewer and Water Departments.

Nick Davis asked Bill Johnson if the Advisory Board had a recommendation on the budget and Mr. Johnson stated not at this time. Duncan Phyfe stated that he was not pleased with how we funded the school this year. He added that it looks like we didn't use the spreadsheet that was used back in FY14. Leo Janssens stated that FY14 was the year that the School's E&D went above the limit and they had to return some money back to the towns. Doug Briggs explained how he reached the budget amount for the schools and noted that it was calculated fairly.

There was more discussion on how the numbers were reached. Duncan Phyfe stated that he wanted to give the Schools another \$70,000. He also noted that he doesn't like the budgeted number for the school but that he would support it.

Resident Natalie Nelson, a parent and teacher, thanked all for attending the meetings. She stated that we need to keep the schools strong with classes less than 30 students and added that at present there are only two classes that are not under 30 students. She encouraged everyone to continue meeting to discuss and that they need to eliminate the drama as the schools are a huge asset to the Town.

Dave Christianson stated that they were meeting the next day where they would see the school choice numbers and would hopefully be closer to Doug Briggs' numbers.

Leo Janssens stated that perhaps they could approve the budget except for the School, line #22. Doug Briggs noted that you can't approve just the other lines. He added that the Advisory Board would be the ones to approve this. Bill Johnson stated that they are still waiting for the State and this is subject to change so maybe they should pencil in all the numbers.

Duncan Phyfe made the motion to post Article 9 as printed and was seconded by Nick Davis. Motion carried.

Mr. Janssens read Article 10 as follows: "To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money for the operating budget of the Ashburnham-Westminster Regional School District, in addition to the sum voted under Article 9 for said operating budget, provided that no funds shall be expended and no bonds shall be issued unless the Town has first voted at an election to exempt this expenditure from the provisions of Proposition 2½, so called, and further provided that the Town of Westminster also votes to approve and fund its proportional share of such additional appropriations." *Nick Davis made the motion to place this article on the warrant and was seconded by Duncan Phyfe. Motion carried.*

Leo Janssens read Article 11 as follows: "To see if the Town will vote to raise and appropriate a sum of money to operate the Water Department for the fiscal year beginning July 1, 2015." Doug Briggs stated that this budget went down by \$20k as they eliminated one employee and that it is also reflected in the Sewer budget. *Duncan Phyfe motioned to place this article on the warrant and to approve... Nick Davis seconded and the motion carried.*

Mr. Janssens read Article 12 as follows: "To see if the Town will vote to raise and appropriate a sum of money to operate the Sewer Department for the fiscal year beginning July 1, 2015." *Nick Davis made the motion to place on the warrant and to approve. Duncan Phyfe seconded and the motion carried.*

Mr. Janssens read Article 13: "To see if the Town will vote to raise and appropriate or appropriate by transfer from available funds the sum of \$451,990 to fund the recommendation of the Capital Planning Committee to include the following:

And to authorize the Board of Selectmen to sell, trade in, or dispose of any equipment being replaced.

Duncan Phyfe motioned to place this article on the warrant and to recommend. Nick Davis seconded and the motion carried.

Mr. Janssens read Article 14 as follows: "To see if the Town will vote to use insurance proceeds to purchase an F550 Ford truck and accessories for the DPW." Doug Briggs stated that this was to replace the vehicle that was totaled this past winter. *Leo Janssens motioned to approve the placement of this article on the warrant and to recommend. Nick Davis seconded and the motion carried.*

Leo Janssens read Article 15: To see if the Town will vote to raise and appropriate or transfer a sum of money to the Capital Fund." Doug Briggs noted that this would be only if we had any extra funds. *Leo Janssens motioned to place this article on the warrant and to recommend. Nick Davis seconded and the motion carried.*

Mr. Janssens read Article 16 as follows: "To see if the Town will vote to amend the AWRSD Regional Agreement." Doug Briggs asked the Board if they wanted this article on the warrant. Dave Christianson stated that this can be discussed at another meeting and that they also had a presentation which they would be happy to review. He added that the School Committee had voted to accept these changes unanimously. He also noted that the changes could not be modified at town meeting. Doug Briggs noted that the wording is incorrect. He said that "foundation budget" should be "net school spending". *Duncan Phyfe made the motion to place this article on the warrant and Nick Davis seconded. Motion carried.*

VII. TOWN ADMINISTRATOR'S REPORT

Doug Briggs stated that he would encourage residents to look at the Town's website at the list of openings to serve on Boards and Committees.

He stated that he has placed the proposed FY16 Budget on the Town's website.

Mr. Briggs stated that the health insurance coverage would stay the same for now due to contractual constraints of the AWRSD teachers' agreement and there would be no savings until the teachers' union negotiations.

He stated that he was pleased to announce that they have chosen a new Treasurer. He stated that we received 7 applications and a review team of Paul Pollastri, Sylvia Turcotte, Carla Clifford and Tanya Gaylord unanimously recommended Kate Stacy from Ashby. He noted that Kate Stacy is the elected treasurer in Ashby and appointed Treasurer/Collector in Townsend. He added that Ms. Stacy will be leaving Townsend and will start here on May 4th and that she is extremely qualified. He asked the Board for their approval to hire Kate Stacy as the Treasurer. *Duncan Phyfe motioned to approve the hiring of Kate Stacy as Treasurer and was seconded by Nick Davis. Motion carried.*

Doug Briggs stated that we are still in line to receive our reimbursement for the Briggs School project in June.

He stated that Guardian Information Technologies is overseeing the installation of a T1 line for our phone system and that it will interconnect all town buildings and will allow for enhanced capabilities and eliminate phone lines. He added that the Public Safety Building will be the center of operations, not the Town Hall and that we would receive better service and eliminate Verizon and AT&T invoices.

He reminded everyone that the Annual Town Meeting is May 5, 2015 at 7:00 p.m. at Oakmont and the deadline to submit warrant articles was March 18th.

Doug Briggs also noted that he will be on vacation the week of April 20th. He added that the next 250th scheduled event is the Ecumenical Service to be held on Sunday, April 12th at 3:00 p.m. at the

Community Church. He also reminded everyone of the cannon firing and that this month it would be fired on Monday, April 20th at approximately 10:00 a.m.

Leo Janssens stated that this was the last meeting for Nick Davis as he has resigned from the Board. He thanked Nick for his service. Mr. Davis explained that he felt it was unfair to stay on the Board if he couldn't dedicate time to the Town. He stated that family and work-related issues made this choice the only option but that he hoped to be back to serve the Town in the future. He thanked the Board members.
