MD opened the meeting of the Ashburnham Conservation Commission under the MA Wetland Protection Act, M.G.L. Chapter 131, Section 40, and in accordance with the Ashburnham Wetlands Protection Bylaw and associated Rules and Regulations.

MD opened to the public hearing for **5 Shamrock Lane (Map 50, Parcel 28)** filed by **Michelle Barry** regarding an **Amendment Request to an Order of Conditions** issued on March 6, 2013 (DEP File No. 092-0877). The request pertains to a revision to the location of the proposed construction of a new single-family dwelling and installation of a new septic system, with both activities within the 100 feet buffer zone.

Owner was represented by Chris MacKenzie, and builders Wes Smith and and Ryan Smith. The preferred location was in the original plan, but was denied (or will likely be denied) by the ZBA. They return to the ZBA on April 10, 2013.

MD reopened the public hearing for Ashby Road (Map 31, Parcel 15), filed by Seth Wright regarding a Notice of Intent for the construction of a new single family home, septic system, and driveway within 100' buffer zone. This public hearing is being continued from March 25, 2012. Present at the public hearing was Seth Wright, who clarified the wetland resource area on the property. Seth explained the wetlands do not occur across the existing woodland road. Seth agreed to replace the existing culvert along the driveway and will install silt fencing instead of a wood chip berm for erosion control during construction.
