<u>Explanation</u>: The Police Department is requesting \$6,000 to replace 6 police officer's bullet resistant vest/body Armor. The material in these vests begin to breakdown and lose their full protection in about 3 years. The Department of Justice recommends that these vests be replaced every 3 to 5 years. The vests being replaced are currently 4 years old. Each vest is specifically measured, cut, and fitted to a particular officer. The price of the vests is on the state bid list and the department applies for 50% reimbursement from the Federal Government, which if received will be turned into the town's general fund.

They have updated new functions that lower the liability to the Town and allows an officer the capability to bring a volatile situation under control in a non-lethal way that has proven to reduce injuries to police officers and the subjects involved.

<u>Explanation:</u> Qualified employees upon retirement from Ashburnham can receive one-half of their accumulated sick time up to 960 hours. This has been a benefit for many years that in 2009 with the addition of short and long disability for non-union personnel was capped. Employees that are hired after July 1, 2009 are no longer eligible for this benefit. With the current employees, total exposure for the "sick leave buyback" retirement benefit is at about \$123,000. Over the next 5 years it is projected that

through retirements \$45,000 will be required. We started funding this account last year and it is hoped that by putting monies into it yearly it will not add stress to our otherwise tight finances.

Article 3 Voted: On motion of Leo Janssens II it was voted to transfer from free cash the sum of \$10,000 to pay employee sick leave buyback retirement benefit.

This increase only affects the sewer users in town and the Ashburnham sewer proposed rate will increase to \$13.75/Hcuft which is \$0.15 greater than the \$13.60/Hcuft rate in 2008.
