- 4. BNE: Lot 9/11A Common Drive. All water flow has been changed to recharge areas. A draft approval was read. Motion by John to waive Section 5.142.9 of the Ashburnham Zoning Bylaws, 2nd by Bob S. All in favor. Motion to accept draft as written with the following amendments. Delete #5 at the top of page 2; #3 change "commons" to "common" and #4 recordation to recording. Motion by John, 2nd by Bob M. All in favor.
- 5. Correspondence Briggs School Task Force. Bob Salo nominated as the Planning Board member to the Task Force.
- 6. ZBA hearings and notices for Ashburnham.
- 7. Winchendon ZBA notice.
- 8. Letter for conservation trust.
- 9. ANR Hosley Road. Motion by Bob S. to endorse the plan as presented, 2nd by Joe K. All in favor.
- 10. ANR presented by Bob M. Bob excused himself from the Board for this presentation. Motion by Bob S. to endorse as presented, 2nd by Rich. All in favor except Bob M. who abstained as it was presented by him.
- 11. Open discussion: Mike Hannon regarding condition #3 of the decision of OSRD regarding the land left to the Conservation Trust. John will consult with Town Counsel. Agenda for next meeting.
- 12. Public Safety Building Committee. Motion by John to waive 5.103.3 for a Public Hearing, 2nd by Rich. All in favor.

All in favor except Bob S. who had to abstain as he was not at the beginning of the hearing. Closed at 8:20 p.m.
- 15. Cashman Hill Estates definitive plan has been submitted. October 13, 2005 will be the date for the Public Hearing.
- 16. A written response will be sent to Mr. & Mrs. Nims regarding the work being done at the Hardware Store.
- 17. Lakeview Estates con't subdivision hearing con't at 8:30 p.m. Waterman Design appeared and several handouts were distributed. There was discussion regarding the fire protection. A 30,000 gallon cistern will be added. All concerns of the Board were discussed and or addressed. John spoke regarding phasing. We would like a clear understanding of the phasing. John requested a letter regarding the sequence of phasing.

Michelle Kerins had a question regarding the time frame for the process. John explained the time frame.
