Planning Board Minutes April 26, 2007

The Planning Board meeting convened at 6:34PM with the following members present: John MacMillan, Chairman; Joseph Kalagher; Bruce Whitney; Tom Ruble and Town Planner Eric Smith. Absent: Robert MacLeod.

7:00 PM – Open Discussion

Tina Sbrega, President and Chief Operating Officer of GFA Federal Credit Union, and Gregg Rosen, of NES Group, appeared before the Board to discuss two possible locations for a branch of GFA Federal Credit Union. One option is to go into the new addition of the hardware store and the other option is the house next to the hardware store. Mr. Rosen stated they are not sure if house is structurally sound enough for a banking institution, but the option to raise the building and rebuild in the same footprint has been discussed. There is a concern that this would displace six apartments if bank chooses that option. Ms. Sbrega and Mr. Rosen stated they would be discussing this concern with the owner. The concern with the store front option is the drive thru window. It was the consensus of the PB that the house option would be the better option. It was also suggested that they contact the DPW Engineer and the Historical Commission.

Chairman MacMillan reviewed the requirements as they proceed with project.

- A motion by Chairman MacMillan, with a second by Kalagher, to refer article 34 back to PB for further study and report at future TM was voted 4 to 0 in favor.
