- Chairman MacMillan opened forum and introduced Town Planner, Eric Smith, to give presentation.
- Eric's presentation discussed "MTC" Wind Energy Maps, the Municipal Light Departments interest in Wind Energy Facility, and model Zoning By-laws.
- Forum was then opened to public for comments.
- Mark Carlisle thanked PB for being pro-active and stated he was disappointed that more people didn't show up. Thinks clearly it could be a huge plus for the town. Sited PEI as example.
