### 7:00 PM – Bresnahan Community Center Committee

The Board met with the committee to discuss the necessary steps for obtaining the building permit for the project. The project is in the RA zoning district and requires a Special Permit and Site Plan review from the Planning Board.

- MacMillan informed the Committee of the requirements of the Special Permit and Site Plan process. The Site Plan portion of the Zoning Bylaw and application and checklist were provided to the committee.
- After discussion, the committee requested that the Public Hearing Notice be placed in "The Community Journal" rather than the Gardner News. Board to determine if this is feasible.
- The Board proposed June 9, 2011 for the date of the Public Hearing, pending the proper application submittal.

## 7:30 PM – Brian Szoc, Szoc Surveyors – Re: Non-Conforming Lots on Lake Shore Drive

- Brian Szoc presented information concerning 3 non-conforming lots on Lake Shore Drive. The lot lines were in serious need of correction. The updated plan would not make the lots conforming, but would make them less non-conforming. Two of the three lots have existing structures. MacMillan indicated that the third lot would need to be marked as "Not A Building Lot"
