- Kathryn Crockett/Lamourluc Pagano Associates and Matt Brassard/Brassard Design and Engineering, Inc. and Jody Staruk, Project Manager/Consigli Construction presented the proposed site plan for the new school.
- Battalion Chief, Robert Salo/Ashburnham Fire Department and Christina Sargent/Historical Commission were also in attendance.
- The Board received comments from the Board of Health, and the Police Department. Their comments did not pertain to the prevue of site plan review.
- Fire Department wanted to make sure there was access to the construction site for public safety vehicles.
- Applicant has applied to Conservation Commission for Notice of Intent.
- AMLP has indicated an existing utility pole will need to be relocated during construction.
- Historical Commission was concerned about design and colors.
- There will be gutters and leaf screens.
- Fire Department is ok with proposed snow storage at rear (West side of building).
- A Fire Protection Assessment has been completed.
- Lighting is Dark Sky compliant.
- There was discussion about construction "Hours of Operation" and "Construction Signage".

- Plan shall meet any Conservation Commission "Notice of Intent".

- Board will require a contact list once construction starts.
- Approval is based on plans presented to Board on November 3, 2001.
- Construction signs should be installed on Williams Road prior to start of construction. Coordinate with Police and Highway.
- Public Safety access at all times during construction.
- Final discussion and vote scheduled for November 17, 2011.
